The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 7 April 2011.

The Shares will be traded on the Stock Exchange under the new stock short name of “INT’L RES ENT” in English and “國際資源實業” in Chinese with effect from 9:00 a.m. on 18 April 2011. The stock code of the Company remains as “1229”.

The website of the Company will be changed from “www.chinasonangol.com.hk” to “www.inren.com.hk” with effect from 14 April 2011 to reflect the Change of Company Name.

Reference is made to the announcement of International Resources Enterprise Limited (formerly known as China Sonangol Resources Enterprise Limited) (the “**Company**”) dated 10 February 2011 and the circular of the Company dated 16 February 2011 (the “**Circular**”) in relation to the proposed Change of Company Name. Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that subsequent to the approval of the special resolution in relation to the proposed Change of Company Name at the SGM held on 11 March 2011, the Certificate of Incorporation on Change of Name and the Certificate of Secondary Name were both issued by the Registrar of Companies in Bermuda on 21 March 2011 respectively certifying that the Company's change of name to "International Resources Enterprise Limited" and the Company's registration with secondary name "國際資源實業有限公司" both took effect on 16 March 2011. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 7 April 2011 confirming the registration of the new name of the Company "International Resources Enterprise Limited also known as 國際資源實業有限公司" in Hong Kong under Part XI of the Companies Ordinance (Chapter 32, Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The existing certificates of securities in issue bearing the former name of the Company will continue to be evidence of title of such securities and will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of existing certificate of securities of the Company for new certificates bearing the new name of the Company. With effect from 18 April 2011, share certificates of the Company will be issued in the new name of the Company.
