POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 20 AUGUST 2024

The board (the “**Board**”) of directors (the “**Directors**”) of Nan Nan Resources Enterprise Limited (the “**Company**”) would like to announce that at the annual general meeting of the Company held at 21/F., Grand Millennium Plaza, 181 Queen’s Road Central, Sheung Wan, Hong Kong on Tuesday, 20 August 2024 at 11:30 a.m. (the “**AGM**”), all the ordinary resolutions and the special resolution as set out in the notice of the AGM dated 26 July 2024 were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll.

As at the date of the AGM, the total number of issued shares of the Company (the “**Shares**”) was 765,373,584 Shares, which was the total number of Shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no Shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no Shareholder was required under the Listing Rules to abstain from voting at the AGM. No Shareholder has stated his/her intention in the circular of the Company dated 26 July 2024 to vote against any of the resolutions proposed at the AGM.
