TO ALL SHAREHOLDERS

On behalf of the board of directors (the "Directors") (the "Board") of Nan Nan Resources Enterprise Limited (the "Company"), I present to you the audited consolidated final results of the Company and its subsidiaries (collectively the "Group") for the year ended 31 March 2022 (the "Year").

RESULTS AND DIVIDENDS

The below summaries the results and dividends of the Group for the years ended 31 March 2022 and 31 March 2021 respectively:

- For the Year, the Group recorded a revenue of approximately HK\$300,241,000 (2021: approximately HK\$130,521,000), gross profit of approximately HK\$162,596,000 (2021: approximately HK\$54,607,000) and net profit of approximately HK\$66,000,000 (2021: net loss of approximately HK\$2,208,000) respectively. The Board does not recommend the payment of any dividend for the Year (2021: Nil).
- Profit for the Year of the Group was approximately HK\$66,000,000 (2021: loss of approximately HK\$2,208,000), representing an upturn of approximately HK\$68,208,000 as compared with the previous year. The upturn was mainly due to the net effect of the following:
 - the exchange loss of approximately HK\$4,091,000 (2021: exchange gain of approximately HK\$7,979,000);

- i) the turnaround from income tax credit of approximately HK\$14,326,000 in the previous year to income tax expenses of approximately HK\$22,940,000 for the Year as the Group reached tax authority in the People's Republic of China (the "Mainland China") for a preferential tax treatment on the deductibility of certain expenses incurred during the year ended 31 March 2020, and accordingly a tax refund was received from the relevant tax authority and was recognised as income tax credit for the year ended 31 March 2021, while the significant enterprise income tax was charged after the utilisation of all tax losses brought forward and the recognition of significant deferred tax liabilities of intangible assets for the Year.

BUSINESS OVERVIEW

For the Year, the Group was engaged in three business segments, (1) coal mining business; (2) renewable energy business and (3) IT Services (as defined below) business. Our main business is coal mining and sales of coal in Xinjiang Uygur Autonomous Region (“Xinjiang”) of the People’s Republic of China (the “Mainland China”). Xinjiang is remote from major industrial cities in the Mainland China, and hence coal produced in Xinjiang is mainly consumed locally due to the logistic and the transportation costs. On 8 October 2018, we completed the acquisition of NEFIN Leasing Technologies Limited and its wholly owned subsidiary, NEFIN Technologies (Malaysia) Sdn. Bhd. (together the “NEFIN Group”) which is principally engaged in renewable energy solutions in Malaysia. We further allocated resources into the solar energy projects since then so as to enable higher efficiency together with the existing solar assets. On 23 April 2019, we completed the acquisition of Harbour Group Holdings Limited (“Harbour Group Holdings”) and its subsidiaries (collectively the “Harbour Group”) which is principally engaged in the provision of information technology (“IT”) outsourcing, consultancy and technical services (together referred to as “IT Services”) mainly in Hong Kong with expanding business in the United Kingdom (“UK”), Malaysia and Singapore. Our Group will continue our focus on developing the existing business. In the long run, we will aspire and strive to grow into an enterprise with a diversified business.

MAJOR EVENTS

Acquisition of the New Mining Right of the Enlarged Kaiyuan Mine

As disclosed in the announcements of the Company dated 11 November 2011, 21 March 2012, 15 June 2012, 21 March 2014, 15 August 2017, 28 March 2018, 14 December 2018, 31 December 2018, 15 May 2019, 31 May 2019, 4 November 2019 and 15 November 2019, the Group negotiated with the Department of Natural Resources of Xinjiang Uygur Autonomous Region* (新疆維吾爾自治區自然資源廳) of the Mainland China (the “Xinjiang Natural Resources Department”) regarding the Optimization and Upgrading Plan# relating to the Kaiyuan Open Pit Coal Mine (the “Kaiyuan Mine”) (i.e. the operating coal mine of the Group in Xinjiang), in particular, to increase the mining area of the Kaiyuan Mine and obtain the corresponding new mining right.

“Optimization and Upgrading Plan” was previously referred to as “Management Restructuring Plan” in the announcement of the Company dated 11 November 2011 and in the announcements, notices, circulars, interim reports and annual reports of the Company thereafter.

業務概覽

於本年度，本集團從事三個業務分類：(1)煤礦業務；(2)可再生能源業務；及(3)資訊科技服務(定義見下文)業務。我們的主要業務為於中華人民共和國(「中國內地」)新疆維吾爾自治區(「新疆」)從事煤礦開採及煤炭銷售。新疆遠離中國內地主要工業城市，因此，基於物流及運輸成本之因素，新疆所產煤炭主要在當地使用。於二零一八年十月八日，我們完成有關新能源租賃科技有限公司及其全資附屬公司NEFIN Technologies (Malaysia) Sdn. Bhd. (統稱為「新能源集團」)(主要於馬來西亞從事可再生能源解決方案業務)的收購事項。自始我們進一步分配資源於太陽能項目，連同現有的太陽能資產能夠實現更高的效益。於二零一九年四月二十三日，我們完成有關港海控股有限公司(「港海控股」)及其附屬公司(統稱「港海集團」)(主要業務為主要於香港提供的資訊科技(「資訊科技」)外包、諮詢及技術服務(統稱「資訊科技服務」)以及於英國(「英國」)、馬來西亞以及新加坡的拓展業務)的收購事項。本集團將繼續專注發展現有業務。長遠而言，我們將銳意及致力發展成為一間從事多元化業務的企業。

重大事項

收購經擴大凱源煤礦之新採礦權

誠如本公司日期為二零一一年十一月十一日、二零一二年三月二十一日、二零一二年六月十五日、二零一四年三月二十一日、二零一七年八月十五日、二零一八年三月二十八日、二零一八年十二月十四日、二零一八年十二月三十一日、二零一九年五月十五日、二零一九年五月三十一日、二零一九年十一月四日及二零一九年十一月十五日之公告所披露，本集團與中國內地新疆維吾爾自治區自然資源廳(「新疆自然資源廳」)磋商凱源露天煤礦(「凱源煤礦」)(即於新疆經營本集團之煤礦)之優化及升級方案#，尤其是擴大凱源煤礦之開採面積及取得相應之新採礦權。

「優化升級方案」之前於本公司日期為二零一一年十一月十一日之公告以及本公司其後之公告、通告、通函、中報及年報中稱為「管理重組計劃」。

MAJOR EVENTS (continued)**Acquisition of the New Mining Right of the Enlarged Kaiyuan Mine (continued)**

- (i) Mulei County Kai Yuan Company Limited* (木壘縣凱源煤炭有限責任公司) ("Kaiyuan Company"), an indirect wholly-owned subsidiary of the Company, as the transferee and Xinjiang Natural Resources Department as the transferor entered into the transfer agreement (the "Transfer Agreement") dated 2 December 2019, pursuant to which Kaiyuan Company acquired the new mining right (the "New Mining Right") of the Kaiyuan Mine with an enlarged mining area (including the original mining area of approximately 1.1596 km² of 4.1123 km² in Xinjiang (the "Enlarged Kaiyuan Mine") for 30 years from August 2019 to August 2049 from the Xinjiang Natural Resources Department to conduct mining activities at the Enlarged Kaiyuan Mine at a consideration of Renminbi ("RMB") 160,978,000 (the "Acquisition");
- (ii) the estimated coal resources of the Enlarged Kaiyuan Mine are 41.6433 million tonnes for the mining life of 30 years under the Transfer Agreement;
- (iii) the new mining permit (the "New Mining Permit") in respect of the New Mining Right with mining term of 1 year from 21 December 2018 to 21 December 2019 regarding the New Mining Right was granted to Kaiyuan Company on 3 November 2018, which has been renewed for two years from 21 December 2019 to 21 December 2021; On 10 October 2021, the New Mining Right has been further renewed for ten years from 11 October 2021 to 11 October 2031;
- (iv) Kaiyuan Company has the right to apply for the renewal of New Mining Permit for the remaining period of the New Mining Right under the Transfer Agreement;
- (v) the consideration of RMB160,978,000 shall be settled in cash and paid by Kaiyuan Company to the Xinjiang Natural Resources Department in fifteen instalments: (a) the first instalment in an amount of RMB32,200,000 was paid by Kaiyuan Company; (b) the second to fourteenth instalments in an amount of RMB9,200,000 each shall be paid before 20 November of every year from 2020 to 2032; and (c) the last instalment in an amount of RMB9,178,000 shall be paid before 20 November 2033;
- (vi) the Acquisition constituted a very substantial acquisition for the Company under the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited (the "Listing Rules") and further information on the Acquisition was disclosed in the circular dated 19 August 2020; and

重大事項(續)**收購經擴大凱源煤礦之新採礦權(續)**

- (i) 本公司間接全資附屬公司木壘縣凱源煤炭有限責任公司(「凱源公司」)(作為受讓方)與新疆自然資源廳(作為出讓方)訂立日期為二零一九年十二月二日之出讓協議(「出讓協議」)。據此，凱源公司向新疆自然資源廳收購凱源煤礦於新疆之經擴大礦區(包括原礦區約1.1596平方公里)4.1123平方公里(「經擴大凱源煤礦」)之新採礦權(「新採礦權」)，年期由二零一九年八月起至二零四九年八月止為期三十年，以於經擴大凱源煤礦進行採礦業務，代價為人民幣(「人民幣」)160,978,000元(「收購事項」)；
- (ii) 根據出讓協議，就30年之開採壽命而言，經擴大凱源煤礦之估計煤礦資源為41.6433百萬噸；
- (iii) 凱源公司於二零一八年十一月三日獲授有關新採礦權之新採礦許可證(「新採礦許可證」)(開採期限由二零一八年十二月二十一日起至二零一九年十二月二十一日止為期一年)，該許可證已重續兩年，由二零一九年十二月二十一日起至二零二一年十二月二十一日止；於二零二一年十月十日，新採礦權已再次重續，由二零二一年十月十一日至二零三一年十月十一日止，為期十年；
- (iv) 根據出讓協議，凱源公司有權就新採礦權之餘下期限申請重續新採礦許可證；
- (v) 代價人民幣160,978,000元將由凱源公司分十五期向新疆自然資源廳以現金結付：(a)第一期金額人民幣32,200,000元由凱源公司支付；(b)第二至十四期每期金額人民幣9,200,000元將於二零二零年至二零三二年期間每年十一月二十日前支付；及(c)最後一期金額人民幣9,178,000元將於二零三三年十一月二十日前支付；
- (vi) 根據香港聯合交易所有限公司證券上市規則(「上市規則」)，收購事項構成本公司之非常重大收購事項，而有關收購事項之進一步資料已於日期為二零二零年八月十九日之通函內披露；及

(vii) as part of the Transfer Agreement, Kaiyuan Company is required to pay a supplemental resources fee of RMB76,502,500 (the "Resources Fee") to the Xinjiang Natural Resources Department for 19.8 million tonnes of coal of Kaiyuan Mine, which represented the difference between the accumulated output of 23.65 million tonnes of the Kaiyuan Mine at the end of 2017 and the output of 3.8819 million tonnes (Resources Fee of such output had been paid by Kaiyuan Company to the Xinjiang Natural Resources Department) and recognised in the profit or loss for the year ended 31 March 2020. Based on the advice given by the legal adviser of the Company as to the laws of the Mainland China, other than the payment of the Resources Fee, Kaiyuan Company will not be subject to any fees relating to the original Kaiyuan Mine pursuant to the terms of the Transfer Agreement.

Temporary Suspension of Enlarged Kaiyuan Mine

As disclosed in the announcements of the Company dated 20 December 2019 and 16 March 2020, the sales and operation of the Enlarged Kaiyuan Mine was temporarily suspended since 21 December 2019 (the "Temporary Suspension") due to the expiry of the New Mining Permit on 21 December 2019 and the delay in renewal of the New Mining Permit.

The New Mining Permit was renewed in March 2020 and the resumption application has been approved by the Production Safety Supervision and Administration Bureau* (安全生產監督管理局) ("Safety Bureau") of the Xinjiang Zhundong Economic and Technological Development Zone* (新疆准東經濟技術開發區) ("Economic Zone") on 2 August 2020. On 2 August 2020 the approval on the resumption application issued by the Safety Bureau of the Economic Zone was received and was allowed to resume mining operations and sales.

References are made to announcements of the Company dated 11 March 2019 and 23 April 2019 and the circular of the Company dated 1 April 2019 in relation to the acquisition of shares and subscription of new shares in Harbour Group Holdings.

(vii) 作為出讓協議之一部分，凱源公司須就凱源煤礦之19.8百萬噸煤炭(即凱源煤礦於二零一七年末之累計產出量23.65百萬噸與產出量3.8819百萬噸之間的差額)向新疆自然資源廳支付補充資源費人民幣76,502,500元(「資源費」)(該產出量之資源費已由凱源公司向新疆自然資源廳支付)，並已於截至二零二零年三月三十一日止年度損益內確認。根據本公司有關中國內地法律的法律顧問所給予之意見，除支付資源費外，根據出讓協議之條款凱源公司毋須支付任何與原凱源煤礦有關之費用。

暫停經擴大凱源煤礦

誠如本公司日期為二零一九年十二月二十日及二零二零年三月十六日之公告所披露，由於新採礦許可證於二零一九年十二月二十一日到期及重續新採礦許可證延期，故自二零一九年十二月二十一日起曾經暫停經擴大凱源煤礦之銷售及營運(「暫停」)。

新採礦許可證已於二零二零年三月獲重續，而復產申請已於二零二零年八月二日由新疆准東經濟技術開發區(「經濟區」)的安全生產監督管理局(「安全局」)所批准。於二零二零年八月二日，經濟區安全局批准復工復產，獲准恢復採礦經營及銷售。

收購港海控股的股份及認購其新股份

茲提述本公司日期為二零一九年三月十一日及二零一九年四月二十三日之公告以及本公司日期為二零一九年四月一日之通函，內容有關收購港海控股之股份及認購其新股份。

On 11 March 2019, (i) Ample Talent Ventures Limited (“Ample Talent”), an indirect wholly-owned subsidiary of the Company, entered into a sale and purchase agreement (the “Sale and Purchase Agreement”) with an independent third party (the “Vendor”), pursuant to which the Vendor conditionally agreed to sell, and Ample Talent conditionally agreed to purchase 80% shareholding interest in Harbour Group Holdings at a consideration of HK\$35,712,000 (the “Harbour Group Acquisition”); and (ii) Ample Talent and Harbour Group Holdings entered into a subscription agreement, pursuant to which Harbour Group Holdings conditionally agreed to issue and allot to Ample Talent, and Ample Talent conditionally agreed to subscribe for 450 ordinary shares of Harbour Group Holdings, representing approximately 4.5% of the total number of shares of Harbour Group Holdings in issue as at the date of subscription agreement at an aggregate subscription price (the “Subscription Price”) of HK\$2,008,800 (the “Subscription”). The Company indirectly interests in 80.86% shares of Harbour Group Holdings in issue upon completion of the Harbour Group Acquisition and Subscription on 23 April 2019.

The consideration for the Harbour Group Acquisition was settled in cash of HK\$28,512,000 by Ample Talent to the Vendor and the remaining amount of HK\$7,200,000 by means of the issue of the three promissory notes (“Promissory Note(s)”), each in the principal amount of HK\$2,400,000 by the Company to the Vendor. The Subscription Price was settled in cash.

Harbour Group consists of Harbour Group Holdings, Harbour Group (Singapore) Pte. Ltd., Harbour Group Consulting (UK) Limited, HGH Technology Sdn. Bhd., Mountain Managed Cloud Consulting Limited and Vanguard Business Services Limited. Harbour Group is principally engaged in the provision of IT Services mainly in Hong Kong with expanding business in the UK, Malaysia and Singapore. The Directors are of the view that the Harbour Group Acquisition and the Subscription can broaden the Group's revenue base and benefit from the diversified return in future. The Harbour Group Acquisition and the Subscription constituted a business combination and was accounted for using the acquisition method under Hong Kong Financial Reporting Standard (“HKFRS”) 3 *Business Combinations*.

收購港海控股的股份及認購其新股份(續)

於二零一九年三月十一日，(i)裕智創投有限公司(「裕智創投」)(為本公司間接全資附屬公司)與獨立第三方(「賣方」)訂立買賣協議(「買賣協議」)，據此，賣方有條件同意出售，而裕智創投有條件同意購買港海控股80%的股權，代價為35,712,000港元(「港海集團收購事項」)；及(ii)裕智創投與港海控股訂立認購協議，據此，港海控股有條件同意向裕智創投發行及配發，而裕智創投有條件同意認購港海控股450股普通股(相當於認購協議日期港海控股已發行股份總數約4.5%)，總認購價(「認購價」)為2,008,800港元(「認購事項」)。於二零一九年四月二十三日完成港海集團收購事項及認購事項後，本公司間接擁有港海控股80.86%已發行股份的權益。

港海集團收購事項之代價已由裕智創投向賣方以現金支付28,512,000港元，而餘下7,200,000港元乃由本公司向賣方發行三份承兌票據(「承兌票據」)，各本金額均為2,400,000港元。認購價已以現金結付。

港海集團由港海控股、Harbour Group (Singapore) Pte. Ltd.、Harbour Group Consulting (UK) Limited、HGH Technology Sdn. Bhd.、峻嶺雲端顧問有限公司及領導商業服務有限公司組成。港海集團主要業務為主要於香港提供的資訊科技服務以及於英國、馬來西亞以及新加坡的拓展業務。董事相信，港海集團收購事項及認購事項日後可拓寬本集團的收益基礎，並從多元化回報中受益。港海集團收購事項及認購事項構成業務合併，並已根據香港財務報告準則(「香港財務報告準則」)第3號業務合併採用收購法入賬。

Acquisition of shares and subscription of new shares in Harbour Group Holdings (continued)

Pursuant to the Sale and Purchase Agreement, the Vendor agreed to guarantee that the audited consolidated net profit generated from operating activities of the Harbour Group in its ordinary and usual course of business, prepared in accordance with HKFRSs (the "Net Profit"), for the years ended 31 December 2018 ("FY2018"), 31 December 2019 ("FY2019") and 31 December 2020 ("FY2020", and each such 12-month period, a "PG 12-Month Period") shall be no less than HK\$7,200,000 per annum (the "Guaranteed Profit"). In the event that the Net Profit during the each PG 12-Month Period is less than the Guaranteed Profit, the Vendor unconditionally and irrevocably undertakes and guarantees, as a continuing obligation, to pay the shortfall multiplied by the ratio of 1.13 to the Group by way of cash and/or setting off the same amount from the amount owed by the Company under the Promissory Note(s) issued to the Vendor.

The profit guarantee for FY2018 was met but the profit guarantee for FY2019 and FY2020 was not fulfilled.

As disclosed in the announcement dated 7 April 2020, the shortfall for FY2019 profit guarantee equals to HK\$2,187,091 (rounded to the nearest dollar). Such amount was deducted from the Promissory Note in the principal amount of HK\$2,400,000 and the outstanding amount of HK\$212,909 (i.e. after deduction of the shortfall amount) of the Promissory Note was paid to the Vendor by the Group.

As disclosed in the announcement dated 7 May 2021, the shortfall for FY2020 profit guarantee equals to HK\$2,538,041 (rounded to the nearest dollar). Such amount was deducted from the Promissory Note in the principal amount of HK\$2,400,000 and the outstanding amount of HK\$138,041 after deduction of the Promissory Note was paid by the Vendor to the Group.

收購港海控股的股份及認購其新股份(續)

根據買賣協議，賣方已同意保證，截至二零一八年十二月三十一日止年度(「二零一八年財政年度」)、二零一九年十二月三十一日止年度(「二零一九年財政年度」)及二零二零年十二月三十一日止年度(「二零二零年財政年度」，而各十二個月期間稱為「溢利保證十二個月期間」)，根據香港財務報告準則編製的港海集團於一般及日常業務過程中經營活動產生的經審核綜合純利(「純利」)將不少於每年7,200,000港元(「保證溢利」)。倘各溢利保證十二個月期間的純利少於保證溢利，賣方無條件及不可撤回地承諾及保證，作為持續義務，以現金及／或自本公司因向賣方發行承兌票據所欠付金額中抵銷同等金額的方式向本集團支付乘以比率1.13的不足金額。

二零一八年財政年度之溢利保證已達成，但二零一九年財政年度及二零二零年財政年度之溢利保證未有實現。

誠如日期為二零二零年四月七日之公告所披露，二零一九年財政年度之溢利保證之不足金額相等於2,187,091港元(約整至最接近的整數)。該金額已從本金額為2,400,000港元的承兌票據中扣除，而本集團已向賣方支付承兌票據的未償還金額212,909港元(即扣除不足金額後)。

誠如日期為二零二一年五月七日的公告所披露，二零二零年財政年度之溢利保證之不足金額相等於2,538,041港元(約整至最接近的整數)。該金額已從承兌票據本金額2,400,000港元中扣除，從承兌票據扣除後的未償還金額138,041港元已由賣方支付予本集團。

PROSPECTS

The Group actively proceeded with the Optimization and Upgrading Plan since 2011 in relation to the New Mining Right of the Enlarged Kaiyuan Mine. The Acquisition enlarged the Group's coal resources and allowed the Group to enhance the development of its sales operations of Kaiyuan Mine in the future. The Directors consider that the transaction is in line with the Group's strategy to expand the coal mining business of the Group. During the Year, Kaiyuan Company successfully renewed and received the renewed New Mining Permit issued by the Xinjiang Natural Resources Department, pursuant to which the term of the mining right of the Enlarged Kaiyuan Mine is renewed for a period of 10 years from 11 October 2021 to 11 October 2031.

In the coming years, there will be (i) a reasonable expected amount of expenditure in capital assets, in particular for the new plants and machines for the environmental protection remedial works and (ii) reasonable expenditure for works required by the Safety Bureau to improve safety standard of our coal mine. Sources of funding are expected to come primarily from the coal sales revenue and external banking facilities of the Group.

In addition to coal mining, the Group has been exploring new markets and seeking to develop its business coverage on technological and renewable energy sectors, in particular, the acquisition of Harbour Group in 2019 and NEFIN Group in 2018. It is one of the objectives of the Group to diversify its business portfolio into sectors offering higher growth momentum.

Due to the subsistence of COVID-19 in Hong Kong and worldwide, we have been facing the difficult business environment, which negatively impacted the growth of our IT Services business in Hong Kong. We hope the COVID-19 situation in Hong Kong will ease in the coming months and our IT Services business will resume its growth.

The Board will continue to keep track of the latest development of the COVID-19 and will use its best endeavors to manage the Group's business portfolio with a view to improving the Group's financial performance and enhance shareholders' value.

I wish to thank my fellow directors, management and staff for their unrelentless efforts for the business development of the Company. On behalf of the Board, I express our sincere gratitude to our shareholders, customers, suppliers, employees and business partners for their continuing support of the Company.

自二零一一年以來，本集團積極進行經擴大凱源煤礦新採礦權之優化升級方案。收購事項已擴大本集團之煤礦資源，有助本集團日後進一步發展凱源煤礦的銷售業務。董事認為，該交易與本集團擴大其煤礦業務之戰略相一致。於本年度，凱源公司成功重續並獲新疆自然資源廳簽發經重續新採礦許可證，據此，經擴大凱源煤礦的採礦權期限重續期由二零二一年十月十一日至二零三一年十月十一日止，為期十年。

來年，本集團將(i)就資本資產預計作出合理開支，尤其是用於環保補救工程之新廠房及機器；及(ii)就安全局要求提高我們煤礦的安全標準所作工作支付合理開支。預期資金來源主要來自本集團之煤炭銷售收益及外部銀行融資。

除煤礦開採外，本集團尋求開拓新市場及擴大其於技術及可再生能源分部之業務範圍，具體而言，於二零一九年收購港海集團及二零一八年收購新能源集團。本集團目標之一是將其業務組合多元化，進入能提供較高增長動力的行業。

由於COVID-19於香港及全球各地持續，我們一直面臨嚴峻的營商環境，此對我們於香港的資訊科技服務業務造成負面影響。我們期望香港的COVID-19情況於未來數月緩和，及我們的資訊科技服務業務回復增長。

董事會將繼續留意COVID-19的最新發展情況，並將盡最大努力管理本集團的業務組合，旨在改善本集團的財務表現及提升股東價值。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

FINANCIAL REVIEW

Revenue

The Group recorded a revenue of approximately HK\$300,241,000 for the Year (2021: approximately HK\$130,521,000). It represents an increase of approximately HK\$169,720,000 or approximately 130.03% as compared with the previous year.

Coal Mining Business

During the Year, revenue of approximately HK\$275,463,000 of the coal mining business is increased by approximately HK\$174,775,000 or approximately 173.58% as compared to approximately HK\$100,688,000 in previous year. The increase in revenue of the coal mining business was mainly due to the strong local demand and facilitated supply arrangement by the local authorities; and also increase in selling price. The Group sold approximately 1,988,282 tonnes (2021: approximately 1,438,392 tonnes) of coal during the Year, increased by approximately 38.23% in volume compared to that in the previous year.

Renewable Energy Business

During the Year, the renewable energy business recorded a turnover of approximately HK\$3,781,000 (2021: approximately HK\$1,285,000). The increase in revenue of the renewable energy business amounting to approximately HK\$2,496,000 was mainly due to the enhanced production capacity since early 2021.

IT Services Business

During the Year, the IT Services business contributed a revenue of approximately HK\$20,997,000 (2021: approximately HK\$28,548,000). The decrease in revenue of approximately HK\$7,551,000, representing a decrease of approximately 26.45% was mainly due to the subsistence of the COVID-19 in Hong Kong and worldwide.

Cost of services and goods sold

Coal Mining Business

The cost of sales of the coal mining business for the Year was approximately HK\$117,557,000 (2021: approximately HK\$53,913,000). The cost mainly comprises direct labor cost, cost for explosive works, depreciation, amortisation and cost of materials, etc. The increase in cost of sales was mainly in line with the increase in sales volume and selling price during the Year as compared with previous year.

Renewable Energy Business

During the Year, the cost of services of the renewable energy business was approximately HK\$2,129,000 (2021: approximately HK\$517,000). The increase in cost of services of the renewable energy business was mainly due to the enhanced production capacity since early 2021 amounting to approximately HK\$1,612,000.

財務回顧

收益

於本年度內，本集團錄得收益約300,241,000港元（二零二一年：約130,521,000港元），與去年相比增加約169,720,000港元或約130.03%。

煤礦業務

於本年度內，煤礦業務收益約275,463,000港元，與去年約100,688,000港元相比增加約174,775,000港元或約173.58%。煤礦業務收益增加主要由於地方需求旺盛及由地方機關協調的供應安排；亦受惠於售價上升。本集團於本年度銷售約1,988,282噸（二零二一年：約1,438,392噸）煤炭，數量較去年增加約38.23%。

可再生能源業務

於本年度內，可再生能源業務錄得營業額約3,781,000港元（二零二一年：約1,285,000港元）。可再生能源業務收益增加約2,496,000港元主要由於自二零二一年初起產能提高。

資訊科技服務業務

於本年度內，資訊科技服務業務貢獻收益約20,997,000港元（二零二一年：約28,548,000港元）。收益減少約7,551,000港元，相當於減少約26.45%，主要由於香港及全球COVID-19疫情持續。

已售服務及貨品成本

煤礦業務

於本年度，煤礦業務之銷售成本約117,557,000港元（二零二一年：約53,913,000港元）。成本主要包括直接勞動成本、爆破工程成本、折舊、攤銷以及材料成本等。與去年比較，銷售成本增加與本年度銷量及售價增幅大致一致。

可再生能源業務

於本年度內，可再生能源業務之服務成本約2,129,000港元（二零二一年：約517,000港元）。可再生能源業務之服務成本增加主要由於自二零二一年初起產能上升約1,612,000港元。

FINANCIAL REVIEW (continued)**Cost of services and goods sold (continued)****IT Services Business**

During the Year, the cost of services and goods sold of the IT Services business is approximately HK\$17,959,000 (2021: approximately HK\$21,484,000). The decrease in cost of services and goods sold was largely in line with the drop of revenue during the Year, particularly the significant curtail of operations in Malaysia and Hong Kong by the subsidiaries of Harbour Group, as compared with the previous year.

Gross profit

The gross profit of the Group for the Year increased to approximately HK\$162,596,000 (2021: approximately HK\$54,607,000). It represents an increase of approximately HK\$107,989,000 or approximately 197.76% and gross profit margin increased by approximately 12.32% to approximately 54.16% for the Year as compared with the previous year. Coal mining business contributed significantly amounting to approximately HK\$157,906,000 (2021: approximately HK\$46,775,000); IT Services business contributed approximately HK\$3,038,000 (2021: approximately HK\$7,064,000); and renewable energy business contributed approximately HK\$1,652,000 (2021: approximately HK\$768,000).

Other revenue

The Group's other revenue for the Year was approximately HK\$1,305,000 (2021: approximately HK\$8,661,000), representing a decrease of approximately HK\$7,356,000 or approximately 84.93% as compared with last financial year. This is mainly due to the net effect of 1) decrease of interest income on bank deposits substantially from the coal mining business of approximately HK\$4,923,000; and 2) no government grants for the Year (2021: approximately HK\$2,403,000) from the Anti-epidemic Fund set up by the Hong Kong government under an Employment Support Scheme as time-limited financial support to employers to retain employees who may otherwise be made redundant.

Administrative and other operating expenses

The Group's administrative and other operating expenses for the Year was approximately HK\$42,084,000 (2021: approximately HK\$34,505,000), representing an increase of approximately HK\$7,579,000 or approximately 21.96% as compared with the previous year. This was mainly due to the 1) the increase in salaries and bonus and staff welfare of approximately HK\$6,260,000 and 2) the additional maintenance cost and the increase of low-value consumables and accessories of approximately HK\$1,090,000 as a result of the significant increase of sales volume of coal mining business during the Year.

財務回顧(續)**已售服務及貨品成本(續)****資訊科技服務業務**

於本年度內，資訊科技服務業務之已售服務及貨品成本約17,959,000港元(二零二一年：約21,484,000港元)。與去年比較，本年度已售服務及貨品成本減幅與收益減幅基本一致，尤其是港海集團附屬公司於馬來西亞及香港的業務經營大幅縮減。

毛利

本集團於本年度之毛利增加至約162,596,000港元(二零二一年：約54,607,000港元)，較上一財政年度增加約107,989,000港元或約197.76%，而本年度之毛利率較去年增加約12.32%至約54.16%。煤礦業務大幅貢獻約157,906,000港元(二零二一年：約46,775,000港元)，而資訊科技服務業務及可再生能源業務分別貢獻約3,038,000(二零二一年：約7,064,000港元)及約1,652,000港元(二零二一年：約768,000港元)。

其他收益

本集團於本年度之其他收益約1,305,000港元(二零二一年：約8,661,000港元)，較上一財政年度減少約7,356,000港元或約84.93%，此乃主要由於以下各項原因之淨影響：1)煤礦業務的銀行存款利息收入顯著減少約4,923,000港元；及2)本年度並無獲得香港政府「保就業」計劃下抗疫基金的政府補助(二零二一年：約2,403,000港元)，該補助為僱主提供有時限的財務支持，以留聘在其他情況下可能被裁的僱員。

行政及其他經營費用

於本年度，本集團之行政及其他經營費用約42,084,000港元(二零二一年：約34,505,000港元)，較去年增加約7,579,000港元或約21.96%，主要由於1)薪金及獎金以及員工福利增加約6,260,000港元；及2)年內煤礦業務的銷量顯著增加，導致產生額外雜項費用以及低值消費品及配件增加約1,090,000港元。

Profit for the Year

Profit for the Year of the Group was approximately HK\$66,000,000 (2021: loss of approximately HK\$2,208,000), representing an upturn of approximately HK\$68,208,000 as compared with last year. The upturn was mainly due to the net effect of the following:

- a) the exchange loss of approximately HK\$4,091,000 (2021: exchange gain of approximately HK\$7,979,000);
- b) the increase of gross profit by approximately HK\$107,989,000;
- c) the decrease of other revenue by approximately HK\$7,356,000;
- d) the increase of administrative and other operating expenses by approximately HK\$7,579,000;
- e) fair value loss of convertible bond designated as financial liabilities at fair value through profit or loss ("FVPL") of approximately HK\$11,254,000 (2021: approximately HK\$24,857,000); representing a further increase in fair value of convertible bond designated on financial liabilities at FVPL of approximately HK\$11,254,000;
- f) no fair value loss of contingent consideration receivables (2021: approximately HK\$3,648,000);
- g) the increase in the finance costs by approximately HK\$716,000;
- h) impairment loss on goodwill of approximately HK\$5,814,000 (2021: approximately HK\$14,503,000); representing a further impairment loss of goodwill of approximately HK\$5,814,000; and
- i) the turnaround from income tax credit of approximately HK\$14,326,000 in the previous year to income tax expenses of approximately of HK\$22,940,000 for the Year as the Group reached tax authority in the Mainland China for a preferential tax treatment on the deductibility of certain expenses incurred during the year ended 31 March 2020, and accordingly a tax refund was received from the relevant tax authority and was recognized as income tax credit for the year ended 31 March 2021, while the significant enterprise income tax was charged after the utilisation of all tax losses brought forward and the recognition of significant deferred tax liabilities of intangible assets for the Year.

The zero coupon convertible bond (the “Convertible Bond”) of the Company in the principal amount of HK\$200,000,000 was issued on 14 March 2008 with a conversion price of HK\$0.2 per share (subject to adjustments) and maturity date of 17 March 2011 (details of which were set out in the announcements of the Company dated 28 January 2008 and 14 March 2008).

The maturity date of the Convertible Bond was then extended to 13 March 2014, 13 March 2017, 13 March 2020, and further extended to 13 March 2023 (details of which were respectively set out in the circulars of the Company dated 21 February 2011, 13 February 2014, 16 February 2017 and 24 February 2020 and announcements of the Company dated 11 March 2011, 10 March 2014, 7 March 2017 and 11 March 2020).

As at the date of this annual report, the outstanding principal amount of the Convertible Bond is HK\$200,000,000.

The Company conducted valuation for the fair value of the Convertible Bond every financial year after its issuance in compliance with the relevant accounting policies. The Company has engaged ValQuest Advisory Hong Kong Limited (“ValQuest”) as its independent professional valuer for the purpose of assessing the fair value of the Convertible Bond as at 31 March 2022. In assessing the fair value of the Convertible Bond, the binomial option pricing model was adopted and factors including stock price of the Company, specific terms and structure of the Convertible Bond, trading conditions and liquidity of the Convertible Bond, and ancillary effects associated with the exercise or conversion and partial conversion of the Convertible Bond were taken into account. The credit rating of our Company is estimated to be CCC with reference to Standard & Poor’s Corporate Rating Criteria, where Corporate Bond with issuer credit rating from CCC- to CCC+ and similar time to maturity were selected, the discount rate is 14.41% (2021: 13.20%).

Change in fair value of convertible bond designated as financial liabilities at FVPL (Continued)

The fair values of the Convertible Bond were approximately HK\$182,537,000 and approximately HK\$171,283,000 as at 31 March 2022 and 2021, respectively. The amounts were assessed and reviewed by the Directors and reviewed and audited by the auditor of the Company. According to the relevant accounting policies, the increase in fair value of the Convertible Bond represents an increase in liabilities of the Company. The amount of the change in fair value of the Convertible Bond of approximately HK\$11,254,000 was derived by taking the difference between the fair value of the Convertible Bond as at 31 March 2022 and 2021. The significant change in fair value of the Convertible Bond was mainly due to the significant change in the stock price of the Company during the Year and the expected volatility of the stock price of the Company. The closing stock prices of the Company were HK\$0.066 and HK\$0.090 as at 31 March 2022 and 2021, respectively, and the expected volatility of the stock price of the Company was 93.35% and 88.74% based on the historical price volatility of the Company for the financial years ended 31 March 2022 and 2021, respectively.

Segment revenue represents revenue derived from (i) coal mining business, (ii) renewable energy business and (iii) IT Services business.

Coal mining is the major business of the Group at present. It contributed a revenue of approximately HK\$275,463,000 for the Year (2021: approximately HK\$100,688,000), representing an increase of approximately 173.58% as compared with last year.

During the Year, the Group sold approximately 1,988,282 tonnes of coals (2021: approximately 1,438,392 tonnes) with total sales income of approximately HK\$275,463,000 (2021: approximately HK\$100,688,000). Details of sales of coals in tonnes are listed in the below table:

(ii) Renewable Energy Business

Service income from renewable energy business contributed a revenue of approximately HK\$3,781,000 for the Year (2021: approximately HK\$1,285,000). The increase in revenue of the renewable energy business was mainly due to the enhanced production capacity since early 2021.

(iii) IT Services Business

Service income from IT Services business contributed a revenue of approximately HK\$20,997,000 for the Year (2021: approximately HK\$28,548,000). The decrease in revenue was mainly due to the subsistence of the COVID-19 in Hong Kong and worldwide.

The Group owns a mining right located in Xinjiang. The estimated remaining reserve in Kaiyuan Mine (excluding the Enlarged Kaiyuan Mine (as defined in “Major Events”)) was approximately 5.11 million tonnes as at 31 March 2020.

On 2 December 2019, the Transfer Agreement was officially passed by the Xinjiang Natural Resources Department to Kaiyuan Company. According to the Competent Person’s report and valuation report of the Enlarged Kaiyuan Mine dated 19 August 2020, the probable reserve in the Enlarged Kaiyuan Mine was approximately 63.48 million tonnes as at the date of acquisition of the Enlarged Kaiyuan Mine.

During the Year, approximately 1.47 million tonnes of coal was extracted (2021: approximately 1.90 million tonnes).

Total approximate reserve of the mine in Xinjiang as at 31 March 2022 is equivalent to 65.22 million tonnes (i.e. the sum of the estimated remaining coal reserve in Kaiyuan Mine including the Enlarged Kaiyuan Mine) (2021: approximately 66.69 million tonnes).

(a) IT Services CGU

The major goodwill of the Group arises from the acquisition of 80.86% equity interests in Harbour Group on 23 April 2019 with cash-generating unit ("CGU") engaged in IT Services (the "IT Services CGU").

As at 31 March 2022, the Directors assessed the recoverable amount of the IT Services CGU with reference to value-in-use ("VIU") calculations using cash flow projections based on financial budgets and forecasts covering a five-year period and extrapolation of cash flows beyond such period conducted by ValQuest.

(a) IT Services CGU (continued)

As at 31 March 2022, in light of keen competition from the IT Services sector and the subsistence of COVID-19 in Hong Kong and worldwide, which are expected to have a negative impact on the revenue and growth rate of the IT Services CGU, the recoverable amount of the IT Services CGU of approximately HK\$7,898,000 (2021: approximately HK\$18,772,000) fell below its then carrying amount. Accordingly, the goodwill allocated to the IT Services CGU was impaired by approximately HK\$5,814,000 (2021: approximately of HK\$14,503,000) during the Year.

Yet, the IT Services segment would continue to sustain its established foothold in Hong Kong, the UK, Malaysia and Singapore in responding to the business development of its existing customers in the IT Services and also cloud related services, though the Group did not tend to enter into long term written service agreements with these customers. The Group expects the existing customers from the information technology and communication industry worldwide would gradually recover once the pandemic is over. In addition, in view of the Hong Kong government's continuous policy measure to facilitate the multi-faceted development of IT industry in Hong Kong, which includes establishing specific government authorities (i.e. the Innovative and Technology Bureau in 2015) to promote the industry, setting up funding schemes to support industry-oriented research and development and nurturing technological entrepreneurship, the Group expects such measures could aid the recovery of the industry once the COVID-19 is contained.

(b) Renewable Energy CGU

Another major goodwill of the Group is the goodwill arising from the acquisition of 90% equity interests in NEFIN Leasing and its subsidiary on 8 October 2018 with CGU engaged in renewable energy solutions and solar farm development (the "Renewable Energy CGU").

As at 31 March 2022 and 2021, the Directors assessed the recoverable amount of the Renewable Energy CGU with reference to VIU calculations using cash flow projections based on financial budgets and forecasts covering a five-year period and extrapolation of cash flows beyond such period conducted by ValQuest.

(a) 資訊科技服務現金產生單位(續)

於二零二二年三月三十一日，鑒於資訊科技服務分部競爭激烈以及香港及全球各地的COVID-19疫情持續，預期會對資訊科技服務現金產生單位的收益及增長率產生負面影響，故資訊科技服務現金產生單位的可收回金額約7,898,000港元(二零二一年：約18,772,000港元)低於其當時之賬面值。因此，本年度分配至資訊科技服務現金產生單位的商譽減值約為5,814,000港元(二零二一年：約14,503,000港元)。

During the years ended 31 March 2022 and 2021, with reference to valuations conducted by ValQuest using discounted cash flow method, the Directors expected that the VIU of the Coal Mining Assets is higher than its carrying amount by approximately HK\$32,865,000 (2021: approximately HK\$23,773,000) and thus concluded that no impairment loss was recognised during the years ended 31 March 2022 and 2021.

The directors of the Company had also considered the following factors and concluded that no reversal of impairment loss was required for the years ended 31 March 2022 and 2021:

- (a) the impairment loss recognised in previous years was related to the Coal Mining Assets of Kaiyuan Mine (as defined in Note (i) below) before the completion of Optimization and Upgrading Plan (as defined in Note (ii) below);
- (b) the assessment of the VIU of Coal Mining Assets as at 31 March 2022 and 2021 was mainly represented by the VIU of Coal Mining Assets of Enlarged Kaiyuan Mine (as defined in Note (ii) below); and
- (c) there is no comparability for the VIU of Coal Mining Assets as at 31 March 2022 and 2021 with the impairment loss recognised in previous years.

In light of the current mining right which is expiring in August 2049 as disclosed below, the Directors are of the opinion that, based on past experience and current laws and regulations in the Mainland China, the Group is eligible to further renew the mining right without incurring significant incremental cost, given the Group continues to comply with the requirements as required by the relevant local authorities in the Mainland China. In this connection, when assessing the VIU of the Coal Mining Assets, the Directors adopted a cash flow forecast which covers beyond the expiry date, representing the remaining periods of the mine until the expected coal reserves of the mine is fully utilised.

Having considered the sensitivity analysis about the possible outcomes for any mining activities after August 2049 and the likelihood of successful renewal of the mining right with reference to a legal opinion issued by the lawyer in the Mainland China, the Directors considered the risk exposed to the renewal of mining right after August 2049 may not have significant impact on the VIU of the Coal Mining Assets.

In assessing the VIU of the CGUs, the future cash flows of the coal mining business are discounted to the related present values using a pre-tax discount rate that reflects current assessment of the time value of money and the risks specific to such business. Parameters used in the projected cash flows included but were not limited to selling prices and sales volumes of coal, production cost and other expenses, capital expenditure, production plan and discount rate, respectively, which reflected the current conditions of the market and the Group and estimated trend in the future. In particular, the Group may revise the annual production plan and the expected sales volumes of coal adopted in the cash flows projection with reference to the latest government policies announced from time to time.

When evaluating the appropriate discount rate for each of the CGUs, the Capital Asset Pricing Model ("CAPM") had been used. Under CAPM, the appropriate expected rate of return was the sum of the risk-free return and the equity risk premium required by investors to compensate for the market risk assumed. In addition, the expected rate of return of the CGUs was expected to be affected by other firm specific risk factors that are independent of the general market. The cost of equity was determined by the risk-free rate, market return and estimated beta of the CGUs and firm specific risk factors. Therefore, the Group may update the inputs of discount rate and other valuation parameters with reference to the latest market information and the firm's specific risk factors based on the most recent available evidences from the relevant appropriate sources, e.g. the competent person's report on mine reserve.

The as-mined coal from Kaiyuan Mine or Enlarge Kaiyuan Mine is screened to various sizes and to the local thermal coal market. The mine has an established thermal coal sales market with low risk for future sales. The significant customers include thermal coal domestic and industry in the local areas.

Xinjiang is remote from major industrial cities in the Mainland China, and hence coal produced in Xinjiang is mainly consumed locally by customers due to the logistic and the transportation costs. The Group did not enter into long term written service agreements with the existing customers.

However, the management of the Group closely monitors the short-term operation strategy and profit margin of different coal products and, if necessary, modifies the production plan through understanding the local government's policies and the coal market demand. The Group keeps strict control over the costs and expenses to maintain a strong financial position in the coal mining business segment.

SIGNIFICANT INVESTMENTS HELD, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, AND FUTURE PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

Save as otherwise disclosed, there were neither significant investments held as at 31 March 2022 nor material acquisitions and disposals of subsidiaries during the Year.

Save as otherwise disclosed, the Group does not have any future plans for material investments. There will, however, be a reasonable expected amount of expenditure in capital assets, in particular for the new plants and machines for the environmental protection remedial works. Sources of funding are expected to come primarily from the coal sales revenue and also external banking facilities of the Group.

As at 31 March 2022, the Group had pledged its mining right with carrying amount of approximately HK\$128,446,000 (2021: approximately HK\$132,175,000).

FOREIGN EXCHANGE EXPOSURE

The Group mainly earns revenue in RMB, HK\$ and MYR and incurs costs in RMB, HK\$ and MYR. The Group is exposed to foreign exchange risk based on fluctuations between HK\$ and RMB arising from its core operation in the Mainland China as well as HK\$ and MYR arising from its operation in Malaysia. The currency exchange risk for the Year is mainly derived from the net exchange gain on convertible bond designated as financial liabilities at FVPL, which is a result from the currency appreciation of RMB against HK\$. In order to minimise the foreign currency risk exposure between these two currencies, the Group maintained cash balances in both currencies that are sufficient to meet several months' operating cash flows requirements of the Group.

TREASURY POLICIES

Apart from the issuance of Convertible Bond at their face value of HK\$200,000,000 and the interest-bearing borrowings amounting to approximately HK\$37,254,000 (2021: approximately HK\$60,636,000), the Group finances its operation mainly by internal generated resources.

CONTINGENT LIABILITIES

As at 31 March 2022, the Group did not have any material contingent liabilities (2021: Nil).

EMPLOYEES

As at 31 March 2022, the Group had 140 employees (2021: 120) spreading amongst Hong Kong, Malaysia, Singapore, the UK and the Mainland China. Total staff costs (excluding directors' emoluments) for the Year amounted to approximately HK\$38,954,000 (2021: approximately HK\$33,406,000), representing a significant reduction of manpower in Hong Kong and Malaysia under the IT Services segment, and the increase in number of staff in the coal mining business in Xinjiang. Employment relationship has been well maintained by the Group with its employees.

Independent Non-executive Directors

Pursuant to Rules 3.10(1), 3.10(2) and 3.10A of the Listing Rules, the Company has appointed three independent non-executive directors who represent half of the Board and with two of whom hold appropriate professional qualifications or accounting or related financial management expertise.

Code provision A.4.1 of the Code specifies that non-executive directors should be appointed for a specific term, subject to re-election. Two independent non-executive directors, namely Dr. Wong Man Hin Raymond and Mr. Chan Yiu Fai Youdey, were appointed on 25 March 2008. Their service agreements have been extended for one year commencing on 25 March 2022. Mr. Pak Wai Keung Martin, the independent non-executive director, was appointed on 19 September 2017 and the service agreement has been extended for one year commencing from 19 September 2021. However, they are still subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the provisions of the Company's Bye-laws.

The Company has received from each of its independent non-executive directors an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules and after annual assessment by the nomination committee of the Company at a meeting on 23 June 2022, the Company considers that all of the independent non-executive directors are independent.

Audit Committee

CORPORATE GOVERNANCE

The Company is dedicated to maintaining a high standard of corporate governance and the Board is responsible for performing the corporate governance duties as stipulated in the Listing Rules. During the Year, the Board committees had developed and reviewed the Company's policies and practices on corporate governance; reviewed and monitored the training and continuous professional development of Directors and senior management; reviewed and monitored the Company's policies and practices on compliance with legal and regulatory requirements and reviewed the compliance with the Code and disclosure in the Corporate Governance Report.

Nomination Policy

The nomination policy of the Company (the "Nomination Policy") was adopted by the Board and became effective on 9 January 2019.

Objective

- The Nomination Committee may, as it considers appropriate, nominate a number of candidates more than the number of directors to be appointed or re-appointed at a general meeting, or the number of casual vacancies to be filled.

Selection Criteria

- The factors listed below could be used as reference by the Nomination Committee in assessing the suitability of a proposed candidate:
 - Reputation for integrity
 - Accomplishment and experience in the related industry
 - Relevant skills and experience to contribute to the Board
 - Commitment in respect of available time and relevant interest
 - Diversity in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service

企業管治

本公司致力於維持高標準之企業管治，而董事會則負責履行上市規則所規定之企業管治職責。於本年度內，董事委員會已制訂及審閱本公司企業管治之政策及常規，並檢討及監察董事及高級管理人員之培訓及持續專業發展；檢討及監察本公司之政策及常規有否遵守法律及監管規定；及檢討有否遵守守則及於企業管治報告之披露。

提名政策

董事會採納本公司的提名政策（「提名政策」），於二零一九年一月九日生效。

目的

- 提名委員會提名的人選數目可（按其認為適當）超過將於股東大會上委任或重新委任的董事人數，或超過需要填補的臨時空缺數目。

甄選準則

- 提名委員會在評估建議人選的資格時將參考以下因素：
 - 信譽

 - 可投入的時間及相關利益
 - 董事會各方面的多元化，包括但不限於性別、年齡（18歲或以上）、文化及教育背景、種族、專業經驗、技能、知識和服務時長等方面

Selection Criteria (continued)

- These factors are for reference only, and not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person, as it considers appropriate.
- Proposed candidates will be asked to submit the necessary personal information in a prescribed form, together with their written consent to be appointed as a Director and to the public disclosure of their personal data on any documents or the relevant websites for the purpose of or in relation to their standing for election as Directors.
- The Nomination Committee may request candidates to provide additional information and documents, if considered necessary.

Nomination Procedures

- The company secretary of the Company shall call a meeting of the Nomination Committee, and invite nominations of candidates from Board members or senior management if any, for consideration by the Nomination Committee prior to its meeting. The Nomination Committee may also put forward candidates who are not nominated by Board members.
- For filling a casual vacancy, the Nomination Committee shall make recommendations for the Board's consideration and approval.
- A candidate is allowed to withdraw his candidature at any time before the general meeting by serving a notice in writing to the company secretary of the Company.
- The Board shall have the final decision on all matters relating to its recommendation of candidates to stand for election at any general meeting.

- 如要填補臨時空缺，提名委員會須推薦人選供董事會考慮及批准。

- 董事會對於其推薦候選人在股東大會上參選的所有事宜有最後決定權。

DIRECTORS' RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibility to present a balanced, clear and understandable assessment relating to annual and interim reports, inside information and price-sensitive announcements and other financial disclosures under the Listing Rules, and reports to regulators as well as to information required to be disclosed pursuant to statutory requirements. As at 31 March 2022, the Directors are not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the ability of the Company to continue as a going concern. The statement of the external auditor of the Company about its reporting responsibilities on the consolidated financial statements is set out in the Independent Auditor's Report from page 63 to page 73 of this annual report.

RISK MANAGEMENT AND INTERNAL CONTROL

During the Year, the Group has complied with code provision C.2 of the Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the Board oversees management in performing its duties on an ongoing basis. Main features of the risk management and internal control systems are described in the sections below:

Risk Management System

The Group adopts a risk management system which manages the risk associated with its business and operations. The system comprises the following phases:

- Identification: Identify ownership of risks, business objectives and risks that could affect the achievement of objectives.
- Evaluation: Analyze the likelihood and impact of risks and evaluate the risk portfolio accordingly.
- Management: Consider the risk responses, ensure effective communication to the Board and monitor the residual risks persistently.

Based on the risk assessments conducted in 2021/22, no significant risk was identified.

董事確認，彼等之職責為就年度及中期報告、內幕消息及股價敏感公告及上市規則下之其他財務披露、呈交監管機構之報告以及根據法定規定須予披露之資料，提呈中肯、清晰及易懂之評估。於二零二二年三月三十一日，董事未有發現任何有關可能對本公司按持續基準繼續經營之能力構成重大疑問之事件或情況之任何重大不明朗因素。本公司外聘核數師就其對綜合財務報表之申報責任所發出之聲明載於本年報第63至73頁之獨立核數師報告。

風險管理及內部監控

本集團於本年度已遵守守則之守則條文第C.2條，建立適當及有效之風險管理及內部監控系統。管理層負責相關系統之設計、實施和監控，董事會則負責監督管理層持續執行有關職責。風險管理和內部監控系統之主要特點如下面章節所述：

風險管理系統

本集團採用風險管理系統，管理與其業務及營運相關之風險。該系統包括以下各方面：

- 識別：識別風險所屬、業務目標及可能影響達致目標之風險。
- 評估：分析風險之可能性及影響，並相應地評估風險組合。
- 管理：考慮風險應對，確保與董事會有效溝通並持續監督剩餘風險。

根據於二零二一／二二年度進行之風險評估，概無識別到任何重大風險。

Internal Control System

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission (“COSO”) 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components of the framework are shown as follows:

- *Control Environment*: A set of standards, processes and structures to provide the basis for carrying out internal control across the Group.
- *Risk Assessment*: A dynamic and iterative process for identifying and analyzing risks to achieve the Group’s objectives, forming a basis for determining how risks should be managed.
- *Control Activities*: Actions established by policies and procedures to help ensure that management directives to mitigate risks to the achievement of objectives are carried out.
- *Information and Communication*: Internal and external communication to provide the Group with the information needed to carry out day-to-day controls.
- *Monitoring*: Ongoing and separate evaluations to ascertain whether each component of internal control is present and functioning.

內部監控系統

本公司設有內部監控系統，與Committee of Sponsoring Organizations of the Treadway Commission (「COSO」) 二零一三年框架相符。該框架使本集團能夠實現經營之效力及效率、財務報告之可靠性及適用法律法規之遵循之目標。該框架組成部分列示如下：

- *控制環境*：一套可提供本集團實施內部監控基礎之標準、程序及架構。
- *風險評估*：一個識別及分析風險之動態及迭代過程，以達致本集團目標，為確定如何管理風險奠定基礎。
- *監控活動*：通過政策及程序制定之行動，協助確保管理層為實現目標而緩解風險之指令能落實執行。
- *資料及溝通*：內部及外部溝通為本集團提供進行日常監控所需資料。
- *監督*：持續及獨立評估以確定內部監控各組成部分是否存在及發揮作用。

In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures. Certain reasonable measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of disclosure requirements in relation to the Group, which include:

- the access of information is restricted to a limited number of employees on a need-to-know basis. Employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality;
- confidentiality agreements are in place when the Group enters into significant negotiations; and
- the executive Directors are designated persons who speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.

Based on the internal control reviews conducted in 2021/22, no significant control deficiency was identified.

Internal Audit

The Group has an Internal Audit ("IA") function, which is consisted of professional staff with relevant expertise (such as Certified Public Accountant). The IA function is independent of the Group's daily operation and carries out appraisal of the risk management and internal control systems by conducting interviews, walkthroughs and tests of operating effectiveness.

An IA plan has been approved by the Board. According to the established plan, review of the risk management and internal control systems is conducted semi-annually and the results are reported to the Board via Audit Committee afterwards.

內部監控系統(續)

為強化本集團處理內部資料之系統，以及確保其公開披露之真實性、準確性、完整性及適時性，本集團亦採納及執行內部資料政策及程序。本集團亦不時採取若干合理措施，確保有適當之防範措施以避免違反與本集團有關之披露要求，其中包括：

- 資料在需要知情之基礎上，僅限供少數僱員接觸。擁有內部資料之僱員須充分認識彼等之保密義務；
- 本集團進行重大協商時簽訂保密協議；及
- 指定執行董事為與媒體、分析員或投資者等外界人士溝通時代表本公司發言之人士。

根據於二零二一／二二年度進行之內部監控檢討，概無識別到有任何重大監控不足之處。

內部審計

本集團設有內部審計(「內部審計」)職能，由具備相關專業知識之專業員工(例如執業會計師)組成。內部審計職能獨立於本集團日常運作，並通過面談、巡視及進行操作效力測試，對風險管理及內部監控系統進行評估。

董事會已批准一項內部審計計劃。根據既定計劃，每半年對風險管理及內部監控系統進行審查，且之後通過審核委員會將結果向董事會報告。

Effectiveness of the Risk Management and Internal Control Systems

The Board is responsible for the risk management and internal control systems of the Group and ensuring review of the effectiveness of these systems has been conducted semi-annually. Several areas have been considered during the Board's reviews, which include but not limited to:

- (i) the changes in the nature and extent of significant risks since the last annual review, and the Group's ability to respond to changes in its business and the external environment; and
- (ii) the scope and quality of management's ongoing monitoring of risks and of the internal control systems.

The Board, through its reviews and the reviews made by IA function and Audit Committee, concluded that the risk management and internal control systems were effective and adequate during the Year. Such systems, however, are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. It is also considered that the resources, staff qualifications and experience of relevant staff were adequate and the training programmes and budget provided were sufficient.

AUDITOR'S REMUNERATION

The audit works of the Group for the Year were performed by Mazars CPA Limited.

風險管理及內部監控系統之有效性

董事會負責本集團風險管理及內部監控系統，確保每半年對該等系統之有效性進行審查。董事會進行審查時已作出多方面考慮，其中包括但不限於：

- (i) 自上次年度審查後，重大風險性質及程度之改變，以及本集團於其業務及外部環境中應對變化之能力；及
- (ii) 管理層持續監督風險及內部監控系統之範圍及質量。

董事會通過其審查和內部審計職能與審核委員會之審查，認定風險管理和內部監控系統於本年度均屬有效及足夠。然而，該等系統旨在管理而非杜絕未能實現業務目標之風險，並且只能就防止重大失實陳述或損失提供合理而非絕對之保證。資源、員工資歷及相關員工之經驗視作足夠，所提供培訓項目及預算亦屬充裕。

SHAREHOLDER’S COMMUNICATIONS

A shareholders communication policy was adopted on 27 March 2012 to ensure that shareholders are provided with ready, equal and timely access to balanced and understandable information about the Company. The shareholders communication policy is available on the Company’s website. The Company has established various channels of communications with its shareholders such as publication of interim and annual reports, press release and announcement of the latest development of the Company in a timely manner. The annual general meeting provides an opportunity for shareholders to exchange views with the Board. External auditor is also available at the annual general meeting to address shareholders’ queries. Moreover, resolutions are proposed at annual general meeting on each substantially separate issue, including the election of individual Directors.

The 2022 annual general meeting (“AGM”) of the Company will be held on 29 July 2022. A notice of annual general meeting will be sent to the shareholders of the Company at least 20 clear business days before the meeting.

Dividend Policy

The dividend policy of the Company (the “Dividend Policy”) was adopted by the Board and became effective on 9 January 2019.

In proposing any dividend payout, the Company could also take into account, inter alia:

- (a) the Group’s actual and expected financial performance;
- (b) retained earnings and distributable reserves of the Group and each of the members of the Group;
- (c) the level of the Group’s debts to equity ratio, return on equity and the relevant financial covenants;

股東通訊

- (g) the dividends received from the Group's subsidiaries and associates, which in turn will depend on the ability of those subsidiaries and associates to pay a dividend;
- (h) the Group's expected working capital requirements;
- (i) general economic conditions, business cycle of the Group's motion control business and other internal or external factors that may have an impact on the business or financial performance and position of the Group; and
- (j) any other factors that the Board deem appropriate.

The Dividend Policy and the declaration and/or payment of future dividends under the Dividend Policy are subject to the Board's continuing determination that the Dividend Policy and the declaration and/or payment of dividends would be in the best interests of the Group and shareholders, and are in compliance with all applicable laws and regulations. The Board endeavours to maintain a balance between meeting its shareholders' expectations and prudent capital management with a sustainable dividend policy.

The Board could continually review the Dividend Policy and reserves the right in its sole and absolute discretion to update, amend, modify and/or cancel the Dividend Policy at any time. The Dividend Policy shall in no way constitute a legally binding commitment by the Group in respect of its future dividend and/or in no way obligate the Group to declare a dividend at any time or from time to time, there can be no assurance that dividends will be paid in any particular amount for any given period. Even if the Board decides to recommend and pay dividends, the form, frequency and amount will depend upon the abovementioned factors.

股息政策及根據股息政策宣派及／或派付未來股息，須視乎董事會持續認為此股息政策及宣派及／或派付股息符合本集團及股東之最佳利益方可作實，且會遵守所有適用法律及法規之規定。董事會致力憑藉可持續的股息政策，在滿足其股東預期與審慎資本管理之間取得平衡。

董事會將持續審閱股息政策，並保留其唯一及絕對酌情權，可隨時更新、修訂、修改及／或取消股息政策。股息政策絕不會在任何方面構成有關本集團未來股息之具法律約束力承諾及／或絕不會令本集團有義務隨時或不時宣派股息，且概不保證股息將於任何既定期間按任何特定金額派付。即使董事會決定建議及派付股息，但形式、頻率及金額將視乎上述因素而定。

SHAREHOLDERS' RIGHTS

Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition sent to the Company's registered office and its principal office in Hong Kong for the attention of the Board or the company secretary of the Company, to require a special general meeting (the "SGM") to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. The written requisition must state the purposes of the general meeting, signed by the shareholder(s) concerned and may consist of several documents in like form, each signed by one or more of those shareholders. If the requisition is in order, the company secretary of the Company will ask the Board to convene a SGM by serving sufficient notice in accordance with the statutory requirements to all the registered shareholders. On the contrary, if the requisition is invalid, the shareholders concerned will be advised of this outcome and accordingly, a SGM will not be convened as requested.

Shareholder(s) of the Company holding (i) not less than one-twentieth of the total voting rights of all shareholders having the right to vote at the general meeting; or (ii) not less than 100 shareholders, can submit a written request stating the resolution intended to be moved at the AGM or a statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at a particular general meeting. The written request/statements must be signed by the shareholder(s) concerned and deposited at the Company's registered office and its principal office in Hong Kong for the attention of the company secretary of the Company, not less than six weeks before the AGM in the case of a requisition requiring notice of a resolution and not less than one week before the general meeting in the case of any other requisition. If the written request is in order, the company secretary of the Company will ask the Board (i) to include the resolution in the agenda for the AGM; or (ii) to circulate the statement for the general meeting, provided that the shareholder(s) concerned have deposited a sum of money reasonably determined by the Board sufficient to meet the Company's expenses in serving the notice of the resolution and/or circulating the statement submitted by the shareholder(s) concerned in accordance with the statutory requirements to all the registered shareholders. On the contrary, if the requisition is invalid or the shareholder(s) concerned have failed to deposit sufficient money to meet the Company's expenses for the said purposes, the shareholder(s) concerned will be advised of this outcome and accordingly, the proposed resolution will not be included in the agenda for the AGM or the statement will not be circulated for the general meeting.

股東權利

任何於呈遞要求日期持有不少於本公司實繳股本(附有於本公司股東大會投票之權利)十分之一之股東於任何時候均有權向董事會或本公司之公司秘書發出書面要求(方法為將書面要求遞交至本公司之註冊辦事處及香港主要辦事處)，要求董事會召開股東特別大會(「股東特別大會」)以處理有關要求中指明之任何事宜；而該大會應於呈遞該要求後兩(2)個月內舉行。書面要求必須列明股東大會目的，由有關股東簽署，並可包括多份相同形式之文件，而每份文件由一名或以上該等股東簽署。倘要求屬妥當，則本公司之公司秘書將透過根據法定規定向全體已登記股東發出足夠通知要求董事會召開股東特別大會。反之，倘要求屬無效，則有關股東將獲通知此結果，股東特別大會將因此不會應要求召開。

RETIREMENT SCHEME

The Group has arranged for its Hong Kong employees to join the Mandatory Provident Fund Scheme (the “MPF Scheme”), a defined contribution scheme managed by an independent trustee. Under the MPF Scheme, each of the Group (the employer) and its employees make monthly contributions to the MPF Scheme generally at 5% of the employees’ earnings as defined under the Mandatory Provident Fund legislation. The monthly contributions of each of the employer and the employee are subject to a maximum contribution of HK\$1,500 per month (for period after 1 June 2014) and thereafter contributions are voluntary. The Group has no further obligation for post-retirement benefits beyond the contributions.

The employees of the Group’s subsidiaries in the Mainland China are members of the state-managed retirement benefit plan operated by the government of the Mainland China. The subsidiaries contributed certain percentage of basic salaries to the retirement benefits plan to fund the benefits. The Group has no further obligations for the actual payment of pensions or post-retirements benefits beyond these contributions. The state-sponsored retirement plans are responsible for the entire pension obligations payable to retired employees.

Contributions to the above retirement schemes vest immediately. No forfeited contributions under the above retirement schemes is available to reduce the contribution payable by the employer in future years.

REMUNERATION POLICY

Remuneration policy of the Company is reviewed regularly, making reference to market condition and performance of the Company and individual staff (including the Directors). The remuneration policy and remuneration packages of the Directors and management team are reviewed by the Remuneration Committee and the Board which are detailed in the paragraph headed “Remuneration Committee” under the Corporate Governance Report on pages 39 to 40.

RELATED PARTY TRANSACTIONS

The Directors consider that those related party transactions disclosed in Note 32 to the consolidated financial statements did not fall under the definition of “connected transactions” or “continuing connected transactions” (as the case may be) in Chapter 14A of the Listing Rules which are required to comply with any of the reporting, announcement or independent shareholders’ approval requirements under the Listing Rules. The Directors confirmed that the Company has complied with the disclosure requirements in accordance with Chapter 14A of the Listing Rules.

CONNECTED TRANSACTION AND CONTINUING CONNECTED TRANSACTION

During the Year, save as disclosed in the paragraph headed “Convertible Bond” under the Report of the Directors on page 54, the Company did not have any connected transactions or continuing connected transactions which were subject to the reporting requirements under Chapter 14A of the Listing Rules.

DISTRIBUTABLE RESERVES

As at 31 March 2022, the Company had no retained profits available for cash distribution and/or distribution in specie. Under the Companies Act 1981 of Bermuda, the Company's contributed surplus of approximately HK\$128,013,000 may be distributed under certain circumstances. In addition, the Company's share premium account with a balance of approximately HK\$191,534,000 may be distributed in the form of fully paid bonus shares.

MAJOR CUSTOMERS AND SUPPLIERS

For the Year, sales to the Group's five largest customers accounted for 53.04% of the total sales for the Year and sales to the largest customer included therein amounted to 15.25%. Purchases of goods and services from the Group's five largest suppliers accounted for 60.77% of the total purchases for the Year and purchases from the largest supplier included therein amounted to 17.67%.

At no time during the Year, the Directors, their close associates or any shareholders (which to the best knowledge of the Directors own more than 5% of the Company's issued shares) had any beneficial interest in the five largest customers or the five largest suppliers.

The Group would, at least annually, perform impairment assessment of coal mines related non-current assets and the management engaged an independent professional valuer (the "Valuer") to assess the value-in-use of coal mines related non-current assets for the purpose of impairment assessment. The impairment assessment involves the management's estimates in certain areas including the discount rate and the underlying cash flow projection based on the future market supply and demand conditions. Any changes in the management's estimates may result in significant financial impact to the Group.

We have identified the impairment assessment on coal mines related non-current assets as a key audit matter due to significant estimates made by the management in determining the recoverable amounts of the corresponding cash-generating unit.

As set out in Note 13 to the consolidated financial statements, the management concluded that the recoverable amount of the cash-generating unit is higher than its carrying value and no impairment provision was required for the current year.

Our key audit procedures, among others, included:

- (a) evaluating the competence, capabilities and objectivity of the Valuer engaged by the management to assess the value-in-use of coal mines related non-current assets;

As set out in Note 14 to the consolidated financial statements, the management concluded that the recoverable amount of the cash-generating unit was lower than its carrying value and impairment loss on goodwill of approximately HK\$5,814,000 arising from IT Services business had been recognised for the current reporting period.

1. GENERAL

Nan Nan Resources Enterprise Limited (the “Company”) was incorporated in Bermuda as an exempted company with limited liability. The shares of the Company are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). In the opinion of the directors of the Company, its holding company is Ascent Goal Investments Limited (“Ascent Goal”), a company incorporated in the British Virgin Islands (“BVI”) with limited liability and its ultimate holding company is New Bright International Development Limited, a company incorporated in Hong Kong with limited liability. These entities do not produce financial statements available for public use. Its ultimate controlling party is Ms. Fung Yuen Kwan, Veronica.

The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section of the annual report.

The consolidated financial statements for the year ended 31 March 2022 comprise the Company and its subsidiaries (together referred to as the “Group”).

The Company is an investment holding company and the subsidiaries of the Company are principally engaged in (i) mining and sales of coal; (ii) renewable energy solutions; and (iii) information technology (“IT”) outsourcing, consultancy and technical services (together referred to “IT Services”). The principal activities of its subsidiaries are set out in Note 16 to the consolidated financial statements.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of compliance

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. The consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”).

All amounts have been rounded to the nearest thousand, unless otherwise indicated.

1. 一般資料

南南資源實業有限公司(「本公司」)於百慕達註冊成立為一間獲豁免有限公司。本公司股份在香港聯合交易所有限公司(「聯交所」)上市。本公司董事認為，其控股公司為於英屬處女群島(「英屬處女群島」)註冊成立之有限公司晉標投資有限公司(「晉標」)，而其最終控股公司則為於香港註冊成立之有限公司創輝國際發展有限公司。該等實體並未編製可供公眾使用之財務報表。其最終控制方為馮婉筠女士。

本公司註冊辦事處及主要營業地點之地址均披露於年報之公司資料一節。

截至二零二二年三月三十一日止年度之綜合財務報表包括本公司及其附屬公司(統稱「本集團」)。

本公司為投資控股公司，而本公司之附屬公司之主要業務為(i)煤炭開採及銷售；(ii)可再生能源解決方案；及(iii)提供的資訊科技(「資訊科技」)外包、諮詢及技術服務(統稱為「資訊科技服務」)。其附屬公司之主要業務載於綜合財務報表附註16。

2. 主要會計政策

合規基準

該等綜合財務報表已根據香港財務報告準則(「香港財務報告準則」)，包括由香港會計師公會(「香港會計師公會」)頒佈之所有適用之個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋、香港公認會計原則及香港公司條例之披露規定編製。該等綜合財務報表亦遵守聯交所證券上市規則(「上市規則」)之適用披露規定。

Basis of compliance (continued)

The consolidated financial statements have been prepared on a basis consistent with the accounting policies adopted in the 2021 consolidated financial statements except for the adoption of the following new/revised HKFRSs that are relevant to the Group and effective from the current year as set out below.

Adoption of new/revised HKFRSs

The Group has applied, for the first time, the following new/revised HKFRSs:

Amendments to HKAS 39, HKFRSs 4, 7, 9 and 16: Interest Rate Benchmark Reform – Phase 2

The amendments address issues that might affect financial reporting when a company replaces the old interest rate benchmark with an alternative benchmark rate as a result of the interest rate benchmark reform (the “Reform”). The amendments complement those issued in November 2019 and relate to:

- changes to contractual cash flows – a company will not have to derecognise or adjust the carrying amount of financial instruments for changes required by the Reform, but will instead update the effective interest rate to reflect the change to the alternative benchmark rate;
- hedge accounting – a company will not have to discontinue its hedge accounting solely because it makes changes required by the Reform, if the hedge meets other hedge accounting criteria; and
- disclosures – a company will be required to disclose information about new risks arising from the reform and how it manages the transition to alternative benchmark rates.

The adoption of the amendments does not have any significant impact on the consolidated financial statements.

合規基準(續)

除採納下文所載與本集團有關並於本年度生效之新訂／經修訂香港財務報告準則外，該等綜合財務報表乃根據與二零二一年綜合財務報表所採納之會計政策一致之基準編製。

採納新訂／經修訂香港財務報告準則

本集團首次應用以下新訂／經修訂香港財務報告準則：

香港會計準則第39號、香港財務報告準則第4號、第7號、第9號及第16號的修訂本：利率基準改革－第二階段

該等修訂本解決了公司因利率基準改革(「改革」)而以替代基準利率取代舊利率基準時可能對財務報告造成影響的問題。該等修訂本對在二零一九年十一月頒佈的修訂作出補充，並與以下各項有關：

- 合約現金流量變動－公司將毋須就改革要求的變動而終止確認或調整金融工具賬面值，惟須更新實際利率以反映改用替代基準利率；
- 對沖會計－如對沖符合其他對沖會計基準，公司將毋須僅因改革所要求的變動而終止對沖會計；及
- 披露－公司將須披露有關改革產生的新增風險及如何管理過渡至替代基準利率的資料。

採納該等修訂本不會對綜合財務報表造成任何重大影響。

Going concern

In preparing the consolidated financial statements, the directors of the Company have given careful consideration to the future liquidity of the Group in light of the fact that the Group's current liabilities exceeded its current assets by approximately HK\$32,068,000 as at 31 March 2022. There is a material uncertainty related to these matters that may cast significant doubt on the Group's ability to continue as a going concern and, therefore, the Group may be unable to realise its assets and discharge its liabilities in the normal course of business.

The directors of the Company considered that (i) the holder of the convertible bond is the holding company of the Group, Ascent Goal, (ii) after negotiation with Ascent Goal about the extension of the maturity date of the convertible bond, together with past experience of successfully extension for four times in previous years, and (iii) even if the convertible bond was not extended, Ascent Goal had committed to provide financial support to the Group as is necessary to enable the Group to meet its financial obligation as they fall due as alternative, they are therefore of the opinion that the Group will have sufficient working capital to finance its operations and to meet its financial obligations for at least the next twelve months from the date of approval of the consolidated financial statements.

Having regard to the cash flow projection of the Group, which are prepared assuming that the above measure is successful, the directors of the Company are of the opinion that, in the light of the measure taken to-date, together with the expected results of the other measures in progress, the Group will have sufficient funding resources to satisfy its future working capital and other financing requirements. The directors of the Company believe that the aforementioned measure will be successful, based on the continuous efforts by the management of the Group.

However, should the above measure not be able to implement successfully, the Group may not have sufficient funds to operate as a going concern, in which case adjustments might have to be made to reduce the carrying values of the Group's assets to their recoverable amounts, to reclassify the non-current assets and non-current liabilities as current assets and current liabilities, respectively and to provide for any further liabilities which might arise.

持續經營

鑒於於二零二二年三月三十一日，本集團的流動負債超出其流動資產約32,068,000港元，故在編製綜合財務報表時，本公司董事已仔細考慮本集團的未來流動資金。該等事項出現重大不確定因素，可能對本集團持續經營之能力造成重大疑問，因此，本集團或無法於正常業務過程中變現其資產及解除其負債。

本公司董事認為，(i)可換股債券持有人為本集團控股公司晉標；(ii)與晉標就延長可換股債券到期日磋商後，連同過往年度成功延期四次之以往經驗；及(iii)即使並無延長可換股債券，晉標已承諾在需要時向本集團提供財務支持，致令本集團可於到期時履行財務責任，以作為替代方案，彼等因而認為本集團將有充裕營運資金，以撥支其營運及履行其自綜合財務報表批准日期起計至少未來十二個月之財務責任。

經考慮本集團現金流量預測(其乃基於上述措施屬成功之假設而編製)，本公司董事認為，鑒於現時所採取之措施，連同其他正在實施之措施之預期成果，本集團將有充裕資金來源，以達致其未來營運資金及其他資金需求。本公司董事相信，憑藉本集團管理層持續努力，上述措施將會取得成功。

然而，倘上述措施未能成功實施，則本集團或無充足資金持續經營業務，於此情況下，可能須對本集團資產之賬面值作出調整，以將該等賬面值減少至可收回金額，分別將非流動資產及非流動負債重新分類為流動資產及流動負債，並就可能產生之任何其他負債計提撥備。

Basis of measurement

The measurement basis used in the preparation of the consolidated financial statements is historical cost, except for the contingent consideration receivables, which was classified as financial assets measured at fair value through profit or loss (“FVPL”), and the convertible bond designated as financial liabilities at FVPL, which are measured at fair value as explained in the accounting policies set out below.

Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and all of its subsidiaries. The financial statements of the subsidiaries are prepared for the same reporting period as that of the Company using consistent accounting policies.

All intra-group balance, transactions, income and expenses and profits and losses resulting from intra-group transactions are eliminated in full. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Non-controlling interests are presented, separately from owners of the Company, in the consolidated statement of profit or loss and other comprehensive income and within equity in the consolidated statement of financial position. The non-controlling interests in the acquiree, that are present ownership interests and entitle their holders to a proportionate share of the acquiree’s net assets in event of liquidation, are measured initially either at fair value or at the present ownership instruments’ proportionate share in the recognised amounts of the acquiree’s identifiable net assets. This choice of measurement basis is made on an acquisition-by-acquisition basis. Other types of non-controlling interests are initially measured at fair value, unless another measurement basis is required by HKFRSs.

計量基準

除應收或然代價(分類為按公平值列賬並在損益內處理(「按公平值列賬並在損益內處理」)之金融資產)及指定為按公平值列賬並在損益內處理之金融負債之可換股債券如下文會計政策所述按公平值計量外，該等綜合財務報表乃以歷史成本基準編製。

綜合賬目基準

綜合財務報表包括本公司及其所有附屬公司之財務報表。附屬公司之財務報表的報告期間與本公司相同，並採用一致會計政策編製。

所有集團內公司間之結餘、交易和集團內公司間交易所產生之收入及支出、溢利及虧損均全數對銷。附屬公司之業績自本集團取得控制權之日期起綜合入賬，並繼續綜合入賬至該控制權終止日期。

非控股權益乃獨立於本公司擁有人，於綜合損益及其他全面收益表及綜合財務狀況表之權益中呈列。屬現所有權權益並授權持有人於清盤時按比例分佔被收購方之資產淨值之於被收購方之非控股權益可初步按公平值或按現有所有權工具按比例分佔被收購方可識別資產淨值之已確認數額計量。計量基準可按個別收購事項選擇。其他類別的非控股權益初步以公平值計量，惟香港財務報告準則規定須按其他計量基準除外。

Basis of consolidation (continued)

Allocation of total comprehensive income

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income is attributed to the owners of the Company and the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Changes in ownership interest

Changes in the Group's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest determined at the date when control is lost and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests at the date when control is lost. The amounts previously recognised in other comprehensive income in relation to the disposed subsidiary are accounted for on the same basis as would be required if the parent had directly disposed of the related assets or liabilities. Any investment retained in the former subsidiary and any amounts owed by or to the former subsidiary are accounted for as a financial asset, associate, joint venture or others as appropriate from the date when control is lost.

綜合賬目基準(續)

分配全面收益總額

損益及其他全面收益各部分均歸屬於本公司擁有人及非控股權益。全面收益總額歸屬於本公司擁有人及非控股權益，即使此舉會導致非控股權益出現虧絀結餘。

擁有權權益變動

本集團於附屬公司之擁有權權益變動若無導致失去控制權，則按權益交易入賬。控股權益及非控股權益之賬面值作出調整，以反映其於附屬公司之相關權益變動。非控股權益獲調整與已付或已收代價公平值之間之任何差額直接於權益確認，並歸屬於本公司擁有人。

倘本集團失去對附屬公司的控制權，出售時產生的損益按下列兩者的差額計算：(i)於失去控制權當日已收代價的公平值與任何保留權益的公平值的總和；及(ii)於失去控制權當日附屬公司及任何非控股權益的資產(包括商譽)及負債的賬面值。先前於其他全面收益確認的有關所出售附屬公司的金額按與假設母公司直接出售相關資產或負債的同一基準列賬。於前附屬公司保留的任何投資及前附屬公司結欠或欠付前附屬公司的任何金額自失去控制權當日起視適用情況列賬為金融資產、聯營公司、合營企業或其他。

Subsidiaries

A subsidiary is an entity that is controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of the elements of control.

In the Company's statement of financial position which is presented within these notes, an investment in subsidiary is stated at cost less impairment losses. The carrying amount of the investment is reduced to its recoverable amount on an individual basis, if it is higher than the recoverable amount. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units ("CGU") (or groups of CGUs) that is expected to benefit from the synergies of the combination.

A CGU to which goodwill has been allocated is tested for impairment annually, or more frequently when there is an indication that the unit may be impaired. If some or all of the goodwill allocated to a CGU was acquired in a business combination during the current annual period, that unit shall be tested for impairment before the end of the current annual period. If the recoverable amount of the CGU is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit, and then to the other assets of the unit on a pro rata basis based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant CGU, the attributable amount of goodwill is included in the determination of profit or loss on disposal.

附屬公司

附屬公司指本集團控制的實體。當本集團承受或享有由參與實體所得的可變回報，且有能力透過其對實體的權力影響該等回報時，則本集團控制該實體。倘有事實及情況顯示控制因素中的一項或以上出現變動，本集團會重新評估其是否控制被投資公司。

於附屬公司之投資於本公司財務狀況報表(於該等附註呈列)中按成本扣除減值虧損列賬。倘各項投資之賬面值高於可收回款項，則個別削減至其可收回款項。至於附屬公司之業績，本公司按已收及應收股息入賬。

商譽

收購業務產生之商譽按收購業務當日之成本減累計減值虧損(如有)列賬。

就減值測試而言，商譽分配至預期受益於合併協同效應之本集團各現金產生單位(「現金產生單位」)(或現金產生單位組別)。

獲分配商譽之一個現金產生單位會每年進行減值測試，或於出現可能減值之跡象時更頻密地進行減值測試。倘於本年度期間分配至現金產生單位的部分或全部商譽在業務合併過程中獲收購，該單位將於本年度期間結束前進行減值測試。倘現金產生單位之可收回金額少於其賬面值，則減值虧損會先分配以扣減分配予該單位之任何商譽之賬面值，其後按單位內各項資產之賬面值之比例扣減該單位之其他資產。商譽之任何減值虧損直接於損益內確認。已確認之商譽減值虧損不會於往後期間撥回。

當出售相關現金產生單位時，商譽之應佔金額將於釐定出售溢利或虧損金額時考慮在內。

Property, plant and equipment

Property, plant and equipment including leasehold land and buildings held for use in the production or supply of goods or services, or for administrative purposes are stated at cost less accumulated depreciation and accumulated impairment losses, if any. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Repairs and maintenance are charged to profit or loss during the period in which they are incurred.

Depreciation is calculated to write off the cost of items of property, plant and equipment over their estimated useful lives and after taking into account their estimated residual value, using the straight-line method. Where parts of an item of property, plant and equipment have different useful lives, the cost or valuation of the item is allocated on a reasonable basis and depreciated separately.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are expensed in profit or loss during the period in which they are incurred.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

物業、廠房及設備

物業、廠房及設備包括持作生產或供應貨品或服務所用或作行政用途之租賃土地及樓宇，乃按成本減累計折舊及累計減值虧損(如有)列賬。物業、廠房及設備項目之成本值包括其購買價及任何將資產達致可作擬定用途之運作情況及地點之任何直接應佔成本。維修及保養乃於其產生期間於損益支銷。

物業、廠房及設備項目之折舊乃按直線法於其估計可使用年內並經計及其估計剩餘價值後計算，以撇銷其成本。當一項物業、廠房及設備的各部分有不同可使用年期時，該項目的成本或估值乃按合理基準在各部分之間分配，而各部分乃個別地折舊。

僅當有關項目之未來經濟利益有可能流入本集團及該項目之成本能可靠計量時，其後成本計入資產之賬面值或確認為獨立資產(倘適用)。被取代部分之賬面值予以終止確認。所有其他維修及保養乃於其產生期間於損益支銷。

物業、廠房及設備項目於出售時或於預期不會從持續使用該項資產中獲得未來經濟利益時終止確認。任何因出售或棄用物業、廠房及設備項目而產生之收益或虧損按出售所得款項與該資產之賬面值間之差額釐定，並於損益確認。

Intangible assets

Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets with finite useful lives are carried at costs less accumulated amortisation and accumulated impairment losses, if any. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

Mining right

Mining right is stated at cost less accumulated amortisation and accumulated impairment losses and is amortised based on the units of production method utilising only recoverable coal reserves as the depletion base.

無形資產

於業務合併中收購之無形資產

於業務合併中收購及與商譽分開確認之無形資產於收購當日按其公平值作初步確認(視為其成本)。

有限可使用年期之無形資產於初步確認後，按成本減累計攤銷及累計減值虧損(如有)入賬。估計可使用年期及攤銷方法於各報告期間結束時檢討，任何估計變動之影響按預期基準列賬。

終止確認無形資產

無形資產於出售或預計不會從使用或出售該項資產中獲得未來經濟利益時終止確認。因終止確認無形資產而產生之收益及虧損，按出售所得款項淨額與資產賬面值間之差額計量，並於終止確認該資產時於損益內確認。

採礦權

採礦權按成本減累計攤銷及累計減值虧損列賬，並僅根據煤炭可採儲量按生產單位法以剝離基準攤銷。

Stripping activity assets

Stripping costs incurred during the production phase are generally considered to create two benefits, being either the production of inventory or improved access to the ore to be mined in the future. Where the benefits are realised in the form of inventory produced in the period, the production stripping costs are accounted for as part of the cost of producing those inventories.

Where the benefits are realised in the form of improved access to ore to be mined in the future, the costs are recognised as a stripping activity asset and is accounted for as an addition to intangible assets if the following criteria are met:

- (a) it is probable that the future economic benefit (improved access to the ore body) associated with the stripping activity will flow to the entity;
- (b) the entity can identify the component of the ore body for which access has been improved; and
- (c) the costs relating to the stripping activity associated with that component can be measured reliably.

Other production stripping costs are charged to the profit or loss as operating costs as they are incurred.

剝離活動資產

一般而言，於生產階段產生的剝離成本視為帶來兩項利益，即生產存貨，或改善進入日後將開採礦場的通道。倘該等利益在期內以所生產存貨的方式實現，則生產剝離成本入賬為生產該等存貨的成本的一部分。

倘該等利益以改善進入日後將開採礦場的通道的方式實現，則有關成本確認為剝離活動資產，並在符合以下準則時，入賬列為無形資產的增加：

- (a) 剝離活動之相關日後經濟利益(進入礦體的通道得到改善)將有可能流入該實體；
- (b) 該實體可識別礦體中通道獲改善的部分；及
- (c) 能可靠地計量與該部分相關之剝離活動之有關成本。

其他生產剝離成本於產生時計入損益，列作營運成本。

Stripping activity assets (continued)

The stripping activity asset is initially measured at cost, which is the accumulation of costs directly incurred to perform the stripping activity that improves access to the identified component of ore, plus an allocation of directly attributable overhead costs.

If the costs of the inventory produced and the stripping activity asset are not separately identifiable, a relevant production measure is used to allocate the production stripping costs between the inventory produced and the stripping activity asset. This production measure is calculated for the identified component of the ore body (i.e. coal reserves) and is used as a benchmark to identify the extent to which the additional activity of creating a future benefit has taken place. The Group uses the expected volume of waste extracted compared with the actual volume for a given volume of ore production of each component.

The stripping activity asset is subsequently amortised using the unit of production method over the life of the identified component of the ore body that became more accessible as a result of the stripping activity. The stripping activity asset is then carried at cost less accumulated amortisation and accumulated impairment losses, if any.

Renewable energy service contract

Renewable energy service contract is stated at cost less accumulated amortisation and accumulated impairment losses, if any. Amortisation is provided on the straight-line basis over the estimated useful lives of 25 years.

剝離活動資產(續)

剝離活動資產初步以成本計量，該成本乃為改善已識別礦場部分的進入通道而進行的剝離活動所直接產生的累計成本，加上直接應佔的雜項成本。

倘所生產存貨的成本及剝離活動資產不能分開識別，則以相關生產計量在所生產存貨及剝離活動資產之間分配生產剝離成本。該生產計量乃為已識別礦場部分(即煤炭儲量)而計算，並用作識別產生未來利益的額外活動的進度的基準。本集團將預期提取的廢物量與各部分生產某一礦量產生的實際廢物量作比較。

剝離活動資產其後按生產單位法，在因剝離活動而變得更易進入的已識別礦場部分的開採年限內進行攤銷。剝離活動資產其後以成本減累計攤銷及累計減值虧損(如有)列賬。

可再生能源服務合約

可再生能源服務合約按成本減累計攤銷及累計減值虧損(如有)列賬。攤銷按估計可使用年限25年以直線法計提撥備。

Financial instruments

Financial assets

Recognition and derecognition

Financial assets are recognised when and only when the Group becomes a party to the contractual provisions of the instruments and on a trade date basis.

A financial asset is derecognised when and only when (i) the Group's contractual rights to future cash flows from the financial asset expire or (ii) the Group transfers the financial asset and either (a) it transfers substantially all the risks and rewards of ownership of the financial asset, or (b) it neither transfers nor retains substantially all the risks and rewards of ownership of the financial asset but it does not retain control of the financial asset.

Financial assets (except for trade receivables without a significant financing component) are initially recognised at their fair value plus, in the case of financial assets not carried at FVPL, transaction costs that are directly attributable to the acquisition of the financial assets. Such trade receivables are initially measured at their transaction price.

On initial recognition, a financial asset is classified as (i) measured at amortised cost; (ii) debt investment measured at fair value through other comprehensive income ("FVOCI"); (iii) equity investment measured at FVOCI; or (iv) measured at FVPL.

The classification of financial assets at initial recognition depends on the Group's business model for managing the financial assets and the financial asset's contractual cash flow characteristics. Financial assets are not reclassified subsequent to their initial recognition unless the Group changes its business model for managing them, in which case all affected financial assets are reclassified on the first day of the first annual reporting period following the change in the business model.

金融資產

確認及終止確認

金融資產乃當且僅當本集團成為工具合約條文之訂約方時按交易日基準確認。

金融資產於且僅於(i)本集團對該項金融資產產生之未來現金流量之合約權利屆滿時；或(ii)本集團轉讓該項金融資產及(a)本集團已轉移該項金融資產擁有權之絕大部分風險及回報；或(b)本集團既無轉移亦無保留該項金融資產擁有權之絕大部分風險及回報，但並無保留該項金融資產之控制權時取消確認。

金融資產(並無重大融資部分之應收貨款除外)初步按其公平值加(倘金融資產並非按公平值列賬並在損益內處理列賬)直接歸屬於收購金融資產之交易成本確認。有關應收貨款初步按其交易價格計量。

Interest expenses is recognised on an effective interest basis other than financial liabilities classified as at FVPL.

Derivatives embedded in a hybrid contract with a host that is not an asset within the scope of HKFRS 9 are treated as separate derivatives when they meet the definition of a derivative, their economic characteristics and risks are not closely related to those of the host, and the hybrid contract is not measured at FVPL.

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by a group entity are recognised at the proceeds received, net of direct issue costs.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

The Group recognises loss allowances for expected credit losses (“ECL”) on financial assets that are measured at amortised cost which the impairment requirements apply in accordance with HKFRS 9. Except for the specific treatments as detailed below, at each reporting date, the Group measures a loss allowance for a financial asset at an amount equal to the lifetime ECL if the credit risk on that financial asset has increased significantly since initial recognition. If the credit risk on a financial asset has not increased significantly since initial recognition, the Group measures the loss allowance for that financial asset at an amount equal to 12-month ECL.

Measurement of ECL

ECL is a probability-weighted estimate of credit losses (i.e. the present value of all cash shortfalls) over the expected life of the financial instrument.

For financial assets, a credit loss is the present value of the difference between the contractual cash flows that are due to an entity under the contract and the cash flows that the entity expects to receive.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument while 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Where ECL is measured on a collective basis, the financial instruments are grouped based on the past due information or other credit risk characteristics.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that the Group may not receive the outstanding contractual amounts in full if the financial instrument that meets any of the following criteria:

- (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group); or
- (ii) there is a breach of financial covenants by the counterparty.

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Assessment of significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial instrument has increased significantly since initial recognition when contractual payments are more than 30 days past due, except for which the Group has reasonable and supportable information to demonstrate.

Low credit risk

A financial instrument is determined to have low credit risk if:

- (i) it has a low risk of default;
- (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term; and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

Simplified approach of ECL

For trade receivables, the Group applies a simplified approach in calculating ECL. The Group recognises a loss allowance based on lifetime ECL at each reporting date and has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Credit-impaired financial asset

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower.
- (b) a breach of contract, such as a default or past due event.
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider.

The Group writes off a financial asset when the Group has no reasonable expectations of recovering the contractual cash flows on a financial asset in its entirety or a portion thereof. The Group expects no significant recovery from the amount written off. However, financial assets that are written off could still be subject to enforcement activities under the Group's procedures for recovery of amounts due, taking into account legal advice if appropriate. Any subsequent recovery is recognised in profit or loss.

Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts (if any) that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows.

Identification of performance obligations

At contract inception, the Group assesses the goods or services promised in a contract with a customer and identify as a performance obligation each promise to transfer to the customer either:

- (a) a good or service (or a bundle of goods or services) that is distinct; or
- (b) a series of distinct goods or services that are substantially the same and that have the same pattern of transfer to the customer.

A good or service that is promised to a customer is distinct if both of the following criteria are met:

- (a) the customer can benefit from the good or service either on its own or together with other resources that are readily available to the customer (i.e. the good or service is capable of being distinct); and
- (b) the Group's promise to transfer the good or service to the customer is separately identifiable from other promises in the contract (i.e. the promise to transfer the good or service is distinct within the context of the contract).

Timing of revenue recognition

Revenue is recognised when (or as) the Group satisfies a performance obligation by transferring a promised good or service (i.e. an asset) to a customer. An asset is transferred when (or as) the customer obtains control of that asset.

The Group transfers control of a good or service over time and, therefore, satisfies a performance obligation and recognises revenue over time, if one of the following criteria is met:

- (a) the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- (b) the Group's performance creates or enhances an asset (for example, work in progress) that the customer controls as the asset is created or enhanced; or
- (c) the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If a performance obligation is not satisfied over time, the Group satisfies the performance obligation at a point in time when the customer obtains control of the promised asset. In determining when the transfer of control occurs, the Group considers the concept of control and such indicators as legal title, physical possession, right to payment, significant risks and rewards of ownership of the asset, and customer acceptance.

Sales of coals and IT hardware products are recognised at a point in time at which the customer obtains the control of the promised asset, which generally coincides with the time when the goods are delivered to customers and the title is passed.

Service income from renewable energy solutions, IT outsourcing services and IT consultancy and technical services are recognised over time when services are rendered.

Timing of revenue recognition (continued)

For revenue recognised over time under HKFRS 15, provided the outcome of the performance obligation can be reasonably measured, the Group applies the output method (i.e. based on the direct measurements of the value to the customer of the goods or services transferred to date relative to the remaining goods or services promised under the contract) to measure the progress towards complete satisfaction of the performance obligation because the method provides a faithful depiction of the Group's performance, or the input method (i.e. based on the proportion of the actual inputs deployed to date as compared to the estimated total inputs) to measure the progress towards complete satisfaction of the performance obligation because there is a direct relationship between the Group's inputs and the transfer of control of goods or services to the customers, where appropriate, and reliable information is available to the Group to apply the method. Otherwise, revenue is recognised only to the extent of the costs incurred until such time that it can reasonably measure the outcome of the performance obligation.

The following output methods are applied:

- Renewable energy solutions: unit of energy produced
- IT consultancy and technical services: appraisal of progress achieved

The principal input applied in the input method is:

- IT outsourcing services: usage of staff hours by customer

Transaction price: significant financing components

When the contract contains a significant financing component (i.e. the customer or the Group is provided with a significant benefit of financing the transfer of goods or services to the customer), in determining the transaction price, the Group adjusts the promised consideration for the effects of the time value of money. The effect of the significant financing component is recognised as an interest income or interest expense separately from revenue from contracts with customers in profit or loss.

Transaction price: significant financing components (continued)

The Group determines the interest rate that is commensurate with the rate that would be reflected in a separate financing transaction between the Group and its customer at contract inception by reference to, where appropriate, the interest rate implicit in the contract (i.e. the interest rate that discounts the cash selling price of the goods or services to the amount paid in advance or arrears), the prevailing market interest rates, the Group's borrowing rates and other relevant creditworthiness information of the customer of the Group.

The Group has applied the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for the effect of the significant financing component if the period of financing is one year or less.

Contract assets and contract liabilities

If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, the contract is presented as a contract asset, excluding any amounts presented as a receivable. Conversely, if a customer pays consideration, or the Group has a right to an amount of consideration that is unconditional, before the Group transfers a good or service to the customer, the contract is presented as a contract liability when the payment is made or the payment is due (whichever is earlier). A receivable is the Group's right to consideration that is unconditional or only the passage of time is required before payment of that consideration is due.

For a single contract or a single set of related contracts, either a net contract asset or a net contract liability is presented. Contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

本集團經參考(倘適用)合約中隱含利率(即將貨品或服務之現金售價貼現至預付或產生之金額之利率)、現行市場利率、本集團之借貸利率及本集團客戶的其他相關信譽資料確定利率，其與合約開始時本集團與其客戶之間獨立融資交易所反映之利率相符。

本集團已應用香港財務報告準則第15號第63段可行權宜方法，倘融資期間為一年或以下，則不會調整受重大融資成分影響之代價。

合約資產及合約負債

For the Group's businesses, it is common for the Group to receive from the customer the whole or some of the contractual payments before the services are completed or when the goods are delivered (i.e. the timing of revenue recognition for such transactions). The Group recognises a contract liability until it is recognised as revenue. During that period, any significant financing components, if applicable, will be included in the contract liability and will be expensed as accrued unless the interest expense is eligible for capitalisation.

The Group's billing to its customers which are largely in line with the timing of revenue recognition and no significant contract assets are recognised. Contract liabilities in relation to advances from customers are recognised under "Trade and other payables".

Foreign currency translation

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars ("HK\$") for the convenience of the shareholders as the Company is listed in Hong Kong. The Company's functional currency is Renminbi ("RMB").

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

就本集團業務而言，本集團於服務完成前或貨品交付時(即有關交易的收益確認時間)自客戶收取全部或部分合約款項屬常見。於合約負債確認為收益前，本集團確認合約負債。期內，除非利息開支合資格資本化，否則任何重大融資成分(如適用)將計入合約負債並按應計開支支銷。

本集團向客戶開具的發票大致與收益確認時間一致且概無重大合約資產獲確認。與客戶墊款有關之合約負債於「應付貨款及其他應付款項」下確認。

外幣交易

本集團各實體之財務報表內項目均以該實體業務所在主要經濟環境通行之貨幣(「功能貨幣」)計量。由於本公司於香港上市，為方便股東，綜合財務報表以港元(「港元」)呈列。本公司之功能貨幣為人民幣(「人民幣」)。

外幣交易依交易日的當期匯率轉換成功能貨幣入賬。該等交易結算時及按期末匯率轉換以外幣計值的貨幣資產及負債所產生的外匯盈虧在損益確認。

The results and financial position of all the group entities that have a functional currency different from the presentation currency (“foreign operations”) are translated into the presentation currency as follows:

- assets and liabilities for each statement of financial position presented, are translated at the closing rate at the end of each reporting period;
- income and expenses for each statement of profit or loss and other comprehensive income are translated at average exchange rate;
- all resulting exchange differences arising from the above translation and exchange differences arising from a monetary item that forms part of the Group’s net investment in a foreign operation are recognised as a separate component of equity;
- on the disposal of a foreign operation, which includes a disposal of the Group’s entire interest in a foreign operation and a disposal involving the loss of control over a subsidiary that includes a foreign operation, the cumulative amount of the exchange differences relating to the foreign operation that is recognised in other comprehensive income and accumulated in the separate component of equity is reclassified from equity to profit or loss when the gain or loss on disposal is recognised;
- on the partial disposal of the Group’s interest in a subsidiary that includes a foreign operation which does not result in the Group losing control over the subsidiary, the proportionate share of the cumulative amount of the exchange differences recognised in the separate component of equity is re-attributed to the non-controlling interests in that foreign operation and are not reclassified to profit or loss; and
- On all other partial disposals, which includes partial disposal of associates or joint ventures that do not result in the Group losing significant influence or joint control, the proportionate share of the cumulative amount of exchange differences recognised in the separate component of equity is reclassified to profit or loss.

Inventories

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

Impairment of other assets, other than goodwill

Impairment of other assets

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the following assets may be impaired or, except in the case of goodwill, an impairment loss previously recognised no longer exists or may have decreased:

- property, plant and equipment;
- right-of-use assets;
- intangible assets;
- investment in subsidiaries in the Company's statement of financial position.

If any such indication exists, the asset's recoverable amount is estimated.

存貨

存貨按成本與可變現淨值之較低者列賬。

成本採用加權平均成本法計算，並包括所有購買成本、兌換成本及將存貨運至現址及達成現狀之其他成本。

可變現淨值乃日常業務過程中之估計售價減估計完工成本及銷售所需之估計成本。

當售出存貨時，該等存貨之賬面值於確認有關收益之期間內確認為開支。任何由存貨撇減至可變現淨值之金額及所有存貨虧損均於撇減或虧損產生期間確認為開支。任何存貨撇減之撥回金額確認為於撥回期間確認為開支之存貨金額減少。

Impairment of other assets (continued)

Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value-in-use (“VIU”). In assessing VIU, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e., a CGU).

Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the CGU to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of CGUs are allocated first to reduce the carrying amount of any goodwill allocated to the CGU (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or VIU (if determinable).

Reversals of impairment losses

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset’s carrying amount that would have been determined had no impairment loss been recognised in prior periods. Reversals of impairment losses are credited to profit or loss in the period in which the reversals are recognised.

其他資產之減值(續)

計算可收回金額

資產之可收回金額為其公平值減出售成本與使用價值(「使用價值」)間之較高者。於評估使用價值時，估計未來現金流量會採用可反映當時市場對貨幣時間價值及該資產特定風險之除稅前貼現率，貼現至其現值。倘資產所產生之現金流入基本上不能獨立於其他資產所產生之現金流入，則以能獨立產生現金流入之最小資產組別(即現金產生單位)釐定可收回金額。

確認減值虧損

倘資產或其所屬現金產生單位之賬面值超過其可收回金額時，則於損益確認減值虧損。就現金產生單位確認之減值虧損首先予以分配，以減低分配予現金產生單位(或單位組別)之任何商譽之賬面值，其後再按比例減低該單位(或該單位組別)其他資產之賬面值，惟資產之賬面值不會低於其個別公平值減出售成本(如可計量)或使用價值(如可釐定)。

(continued)****Borrowing costs**

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of a qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

與收購、建設或生產需要長時間才可投入擬定用途或銷售之資產直接相關之借貸成本會資本化為該資產成本之一部分。其他借貸成本於其產生期間支銷。

屬於合資格資產成本一部分之借貸成本在用於資產之開支產生、產生借貸成本及使資產投入擬定用途或銷售所必需之準備工作進行期間開始資本化。當使合資格資產投入擬定用途或銷售所必需之絕大部分準備工作中止或完成時，借貸成本便會暫停或停止資本化。

撥備及或然負債

當本集團因過往事件須承擔法定或推定責任，很可能須以經濟利益流出之方式履行有關責任且該金額能可靠估計時，則對不確定時間及金額之負債確認為撥備。倘貨幣之時間價值屬重大，撥備乃按預計履行責任之支出之現值列賬。

倘不大可能導致經濟利益流出或其金額不能可靠估計，則責任披露為或然負債，除非經濟利益流出之可能性極低。可能出現之責任將僅取決於日後是否會發生一項或多項事件，亦披露為或然負債，除非經濟利益流出之可能性極低。

Provision for close down, restoration and environmental costs

One consequence of coal mining is land subsidence caused by the resettlement of the land at the mining sites. Depending on the circumstances, the Group may relocate inhabitants from the mining sites prior to conducting mining activities or the Group may compensate the inhabitants for losses or damage from close down and land subsidence after the sites have been mined. The Group may also be required to make payments for restoration, rehabilitation or environmental protection of the land after the sites have been mined.

Close down and restoration costs include the dismantling and demolition of infrastructure and the removal of residual materials and remediation of disturbed areas. Close down and restoration costs are provided in the accounting period when the obligation arising from the related disturbance occurs, whether this occurs during mine development or during the production phase, based on the net present value of estimated future costs. The cost is capitalised where it gives rise to future benefits, whether the rehabilitation activity is expected to occur over the life of the operation or at the time of close down. The capitalised cost other than that is included in the cost of inventories is amortised over the life of the operation and the increase in the net present value of the provision is included in borrowing costs or other items where appropriate.

Where there is a change in the expected decommissioning and restoration costs, an adjustment is recorded against the carrying value of the provision and related assets, and the effect is then recognised in the consolidated statement of profit or loss and other comprehensive income on a prospective basis over the remaining life of the operation except for the portion included in the cost of inventories. Provisions for close down and restoration costs do not include any additional obligations which are expected to arise from future disturbance. The cost estimates are reviewed and revised at the end of the reporting period to reflect changes in conditions.

關閉、復墾及環境成本撥備

煤礦開採之一個後果為因在礦場搬運泥土而造成土地下陷。視乎各種情況，本集團可於進行開採活動前先將居民遷離礦場，或可於礦場開採後就關閉礦場及土地下陷所造成之損失或損害向居民作出賠償。本集團亦可能須支付礦場開採後之土地復墾、修復或環保費用。

關閉及復墾成本包括拆除及拆卸基礎設施、清理殘餘材料及修復受干擾區域之成本。關閉及復墾成本於產生有關干擾引起之責任之會計期間，按估計未來成本之淨現值計提撥備，而不論該責任是在煤礦開發期間或生產階段產生。有關成本於其產生未來利益時資本化，而不論修復活動預期會在經營期限內或在關閉時產生。資本化成本(計入存貨成本部分除外)按經營期限攤銷，而撥備淨現值之增加則計入借貸成本或其他項目(倘適用)。

倘預期拆除及復墾成本出現變動，撥備及相關資產賬面值將作出調整，所產生影響屆時將於剩餘經營期限內按預期基準於綜合損益及其他全面收益表確認，惟計入存貨成本部分除外。關閉及復墾成本之撥備不包括未來干擾事件預期會產生之任何額外責任。成本估計於報告期間結束時檢討及修正，以反映情況變化。

Leases

The Group assesses whether a contract is, or contains, a lease at inception of the contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

As lessee

The Group applies the recognition exemption to short-term leases and low-value asset leases. Lease payments associated with these leases are recognised as an expense on a straight-line basis over the lease term.

The Group has elected not to separate non-lease components from lease components, and accounts for each lease component and any associated non-lease components as a single lease component.

The Group accounts for each lease component within a lease contract as a lease separately. The Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component.

Amounts payable by the Group that do not give rise to a separate component are considered to be part of the total consideration that is allocated to the separately identified components of the contract.

The Group recognises a right-of-use asset and a lease liability at the commencement date of the lease.

The right-of-use asset is initially measured at cost, which comprises:

- (a) the amount of the initial measurement of the lease liability;
- (b) any lease payments made at or before the commencement date, less any lease incentives received;
- (c) any initial direct costs incurred by the Group; and
- (d) an estimate of costs to be incurred by the Group in dismantling and removing the underlying asset, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories.

本集團對短期租賃及低值資產租賃應用確認豁免。該等租賃相關的租賃付款按直線法於租賃期內確認為開支。

本集團已選擇不從租賃組成部分中分離出非租賃組成部分，並對各個租賃組成部分及任何相關非租賃組成部分入賬作為單獨租賃組成部分。

本集團將租賃合約中各租賃組成部分單獨作為一項租賃項目入賬。本集團將合約代價按租賃組成部分相對獨立價格基準分配至各租賃組成部分。

本集團未產生單獨組成部分之應付款項被視作分配至合約單獨已識別組成部分之總代價之一部分。

本集團於租賃開始日期確認使用權資產及租賃負債。

使用權資產乃按成本進行初始計量，其中包括：

- (a) 租賃負債的初始計量金額；
- (b) 於開始日期或之前所作的任何租賃付款，減已收取的任何租賃優惠；
- (c) 本集團產生的任何初始直接成本；及

Subsequently, the right-of-use asset is measured at cost less any accumulated depreciation and any accumulated impairment losses and adjusted for any remeasurement of the lease liability. Depreciation is provided on a straight-line basis over the shorter of the lease term and the estimated useful lives of the right-of-use asset (unless the lease transfers ownership of the underlying asset to the Group by the end of the lease term or if the cost of the right-of-use asset reflects that the Group will exercise a purchase option – in which case depreciation is provided over the estimated useful life of the underlying asset).

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date of the contract.

The lease payments included in the measurement of the lease liability comprise the following payments for the right to use the underlying asset during the lease term that are not paid at the commencement date:

The lease payments are discounted using the interest rate implicit in the lease, or where it is not readily determinable, the incremental borrowing rate of the lessee.

Subsequently, the lease liability is measured by increasing the carrying amount to reflect interest on the lease liability and by reducing the carrying amount to reflect the lease payments made.

The lease liability is remeasured using a revised discount rate when there are changes to the lease payments arising from a change in the lease term or the reassessment of whether the Group will be reasonably certain to exercise a purchase option.

The lease liability is remeasured by using the original discount rate when there is a change in the residual value guarantee, the in-substance fixed lease payments or the future lease payments resulting from a change in an index or a rate (other than floating interest rate). In case of a change in future lease payments resulting from a change in floating interest rates, the Group remeasures the lease liability using a revised discount rate.

The Group recognises the amount of the remeasurement of the lease liability as an adjustment to the right-of-use asset. If the carrying amount of the right-of-use asset is reduced to zero and there is a further reduction in the measurement of the lease liability, the Group recognises any remaining amount of the remeasurement in profit or loss.

A lease modification is accounted for as a separate lease if:

- (a) the modification increases the scope of the lease by adding the right to use one or more underlying assets; and
- (b) the consideration for the lease increases by an amount commensurate with the stand-alone price for the increase in scope and any appropriate adjustments to that stand-alone price to reflect the circumstances of the particular contract.

當租賃期出現變動而產生租賃付款變動或重新評估本集團是否將合理確定行使購買選擇權時，租賃負債使用經修訂貼現率進行重新計量。

Short-term employee benefits and contributions to defined contribution retirement plans

Salaries, annual bonuses, paid annual leave and the cost of non-monetary benefits are accrued in the period in which the associated services are rendered by employees.

The obligations for contributions to defined contribution retirement scheme in Hong Kong are recognised as expense in profit or loss as incurred. The assets of the scheme are held separately from those of the Group's entities established in Hong Kong in an independently administered fund.

In accordance with the rules and regulations in the People's Republic of China (the "Mainland China"), the employees of the Group's entities established in the Mainland China are required to participate in defined contribution retirement plans organised by local governments. Contributions to those plans are expensed as incurred and other than these monthly contributions, the Group has no further obligation for the payment of retirement benefits to its employees.

薪金、年度花紅、有薪年假以及非貨幣福利之成本於僱員提供相關服務之期間內計提。

香港定額供款退休計劃供款之責任於產生時在損益中確認為開支。該計劃之資產與本集團於香港成立之實體之資產分開，並由獨立管理基金持有。

根據中華人民共和國(「中國內地」)之規則及規例，本集團於中國成立之實體僱員須參與由地方政府組織之定額供款退休計劃。對該等計劃之供款於產生時支銷，而除該等每月供款外，本集團概無向其僱員支付退休福利之其他責任。

Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

Taxation

The charge for current income tax is based on the results for the period as adjusted for items that are non-assessable or disallowed. It is calculated using tax rates that have been enacted or substantively enacted by the end of each reporting period.

Deferred tax is provided, using the liability method, on all temporary differences at the end of each reporting period between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, any deferred tax arising from initial recognition of goodwill; or other asset or liability in a transaction other than a business combination that at the time of the transaction affects neither the accounting profit nor taxable profit or loss is not recognised.

The deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is recovered or the liability is settled, based on tax rates and tax laws that have been enacted or substantively enacted at the end of each reporting period.

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences, tax losses and credits can be utilised.

Deferred tax is provided on temporary differences arising on investment in subsidiaries and associates, except where the timing of the reversal of the temporary differences is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

稅項

即期所得稅開支乃根據期內業績計算，並就無須課稅或不獲寬減之項目調整。即期所得稅開支採用於各報告期末已頒佈或實質頒佈之稅率計算。

本集團就綜合財務報表內資產及負債之稅基與賬面值於各報告期末之所有暫時差額利用負債法計提遞延稅項撥備。然而，初步確認商譽或一項交易(業務合併除外)中之其他資產或負債所產生之任何遞延稅項，倘於交易時不影響會計溢利或應課稅溢利或虧損，則不會予以確認。

遞延稅項資產及負債基於在各報告期末已頒佈或實質頒佈之稅率及稅法，按預期適用於收回資產或清償負債各期間之稅率計量。

倘日後可能有應課稅溢利可供抵銷可扣減之暫時差額、稅項虧損及抵免，則會確認遞延稅項資產。

本集團按於附屬公司及聯營公司之投資所產生之暫時差額計提遞延稅項撥備，惟倘本集團可控制暫時差額之撥回時間及暫時差額不大可能於可見將來撥回則作別論。

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

分類報告

經營分類及財務報表內呈報之各分類項目之金額自定期提供予本集團執行董事之財務資料中識別，旨在將資源分配至本集團之各項業務及評估本集團各項業務及地區之表現。

就財務報告而言，除非分類具備相似之經濟特徵及在產品及服務性質、生產工序性質、客戶類型或類別、用作分配產品或提供服務之方法以及監管環境之性質方面相似，否則各重大經營分類不會彙集計算。個別非重大之經營分類，倘符合上述大部分標準，則可彙集計算。

In the application of the Group's accounting policies, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future and other key sources of estimation uncertainty at the end of reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial period.

Reserve estimates

Reserves are estimates of the amount of products that can be economically and legally extracted from the Group's coal reserves. In order to calculate reserves, estimates and assumptions are required about a range of geological, technical and economic factors, including quantities, grades, production techniques, recovery rates, production costs, transport costs, commodity demand and commodity prices. Estimating the quantity and/or grade of reserves requires the size, shape and depth of ore bodies or fields to be determined by analysing geological data such as drilling samples. This process may require complex and difficult geological judgements and calculations to interpret the data.

該等估計及相關假設會持續予以檢討。如修訂會計估計僅影響修訂期間，則有關估計之修訂在該期間確認，或如修訂影響現時及未來期間，則在修訂期間及未來期間確認。

估計不明朗因素之主要來源

以下為有關未來之主要假設及於報告期間結束時估計不明朗因素之其他主要來源，該等假設及來源存在可能導致對下一個財政期間之資產及負債賬面值須作出重大調整之重大風險。

儲量估計

儲量為可按經濟原則合法自本集團之煤礦儲量取得之估計產品數量。為計算儲量，須就地質、技術及經濟因素範疇作出估計及假設，其中包括數量、品位、生產技術、採收率、生產成本、運輸成本、商品需求及商品價格。估計儲量之數量及／或品位時，須按鑽探採樣等地質數據分析，釐定礦體或礦場之規模、形狀及深度。此工序或涉及繁複艱鉅之地質判斷及計算以解釋有關數據。

Because the economic assumptions used to estimate reserves change from period to period, and because additional geological data is generated during the course of operations, estimates of reserves may change from period to period. Changes in reported reserves may affect the Group's financial results and financial position in a number of ways, including the following:

- (i) asset carrying values may be affected due to changes in estimated future cash flows.
- (ii) depreciation, depletion and amortisation charged to the profit or loss may change where such charges are determined by the units of production basis, or where the useful economic lives of assets change.
- (iii) decommissioning, site restoration and environmental provisions may change where changes in estimated reserves affect expectations about the timing or cost of these activities.
- (iv) the carrying value of deferred tax may change as a result of changes in the asset carrying values as discussed above.

由於估計儲量所用經濟假設會隨著不同期間而改變，而營運過程中會額外產生地質數據，故儲量估計或會隨不同期間而有所變動。呈報儲量之變動可循不同方法影響本集團之財務業績及財務狀況，其中包括下列各項：

- (i) 因估計未來現金流量之變動可能影響資產賬面值。
- (ii) 倘折舊、耗減及攤銷支出按生產單位為基準予以釐定，或資產之可使用經濟年限有所變動，於損益內扣除之折舊、耗減及攤銷可能有所變動。
- (iii) 倘估計儲量之變動影響拆撤、礦場復墾及環保工作預期之時間表或成本，拆撤、礦場復墾及環保撥備可能有所變動。
- (iv) 遞延稅項之賬面值或因上文所討論之資產賬面值改變而有所變動。

Key sources of estimation uncertainty (continued)

Carrying values of property, plant and equipment, right-of-use assets, prepayment for acquisition of property, plant and equipment and intangible assets

The Group's property, plant and equipment, right-of-use assets, prepayment for acquisition of property, plant and equipment and intangible assets are carried at cost less accumulated depreciation, accumulated amortisation and accumulated impairment losses, where appropriate. These carrying amounts are reviewed for impairment whenever internal and external sources of information indicate that the carrying amounts may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and VIU. In estimating the recoverable amounts of assets, various assumptions, including future cash flows to be associated with the non-current assets and discount rates, are made. If future events do not correspond to such assumptions, the recoverable amounts will need to be revised, and this may have an impact on the Group's results of operations or financial position. The impairment assessment of the Group's mining right and stripping activity assets included in intangible assets is further discussed below.

Impairment of mining right and stripping activity assets

The Group assesses each CGU annually to determine whether any indication of impairment exists, which included internal and external sources of information for mining right and facts and circumstances for stripping activity assets. Where an indicator of impairment exists, a formal estimate of the recoverable amount is made, which is considered to be the higher of the fair value less costs of disposal and VIU. These assessments require the use of estimates and assumptions such as long-term commodity prices, discount rates, future capital requirements, exploration potential and operating performance. It is difficult to precisely estimate fair value because quoted market prices are not readily available. In determining the VIU, expected cash flows generated by the asset are discounted to their present value, which require significant judgements and estimates such as sale volume, selling price and amount of operating costs. The management has assessed its CGU as being an individual mine site, which is the lowest level for which cash flows are largely independent of other assets.

估計不明朗因素之主要來源(續)

物業、廠房及設備、使用權資產、收購物業、廠房及設備之預付款項以及無形資產賬面值

本集團之物業、廠房及設備、使用權資產、收購物業、廠房及設備之預付款項以及無形資產按成本減累計折舊、累計攤銷及累計減值虧損(如適用)列賬。倘內部及外界資料來源顯示賬面值可能無法收回，則會檢討該等項目之賬面值是否出現減值。若資產賬面值超過其可收回金額時，會就其差額確認減值虧損。可收回金額為資產公平值減出售成本或使用價值之較高者。在估計資產之可收回金額時作出多項假設，包括與非流動資產有關之未來現金流量及貼現率。倘未來事項與該等假設不符，可收回金額將需要作出修訂，此修訂可能影響本集團之經營業績或財務狀況。計入無形資產之本集團採礦權及剝離活動資產，其減值評估於下文進一步論述。

採礦權及剝離活動資產

本集團每年評估各現金產生單位，以確定是否存在任何減值跡象，包括有關採礦權之內部及外界資料來源、剝離活動資產之實情及情況。倘出現減值跡象，則會作出可收回金額之正式估計，有關金額即公平值減出售成本與使用價值間之較高者。該等評估須採用有關估計及假設，如長期商品價格、貼現率、未來資金需求、勘探潛力及經營表現。由於該等資產可能缺乏現成之市場報價，故難以準確地估計公平值。在釐定使用價值時，資產產生之預期現金流量貼現至其現值，須作出銷量、售價及經營成本等重大判斷及估計。管理層已評估其現金產生單位作為某個別礦場，其為主要獨立於其他資產之現金流量之最低水平。

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the VIU of the CGUs to which the goodwill is allocated. Estimating the VIU requires the Group to make an estimate of the expected cash flows from the CGU and also to choose a suitable discount rate in order to calculate the present value of those cash flows. Details of the estimates used to calculate the recoverable amount are given in Note 14 to the consolidated financial statements.

Loss allowance for ECL

The management of the Group estimates the loss allowance for trade receivables and other receivables by using various inputs and assumptions including risk of a default and expected loss rate. The estimation involves high degree of uncertainty which is based on the Group's historical information, existing market conditions as well as forward-looking estimates at the end of each reporting period. Where the expectation is different from the original estimate, such difference will impact the carrying amount of trade receivables. Details of the key assumption and inputs used in estimating ECL are set out in Note 31 to the consolidated financial statements.

Fair value measurements and valuation process

The Group's convertible bond is measured at fair value for financial reporting purposes. The directors of the Company have to determine the appropriate valuation techniques and inputs for fair value measurements.

In estimating the fair value of a liability, the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Group engages third party qualified valuer to perform the valuation. The directors of the Company work closely with the qualified external valuer to establish the appropriate valuation techniques and inputs to the model.

估計不明朗因素之主要來源(續)

商譽減值

本集團至少每年確定商譽是否減值。這需要對獲分配商譽的現金產生單位的使用價值進行估計。為了估計使用價值，本集團需要對現金產生單位的預期現金流量進行估計，並選擇適當的貼現率，以計算上述現金流量現值。有關計算可收回金額所使用的估計詳情載於綜合財務報表附註14。

預期信貸虧損之虧損撥備

本集團管理層使用各種輸入數據及假設(包括違約風險及預期虧損率)估計應收貨款及其他應收款項的虧損撥備。估計涉及高度不確定性，該不確定性乃基於本集團的過往資料、現有市況及各報告期末的前瞻性估計。倘預期與原估計有所不同，該差額將影響應收貨款的賬面值。有關估計預期信貸虧損時所使用的主要假設及輸入數據詳情載於綜合財務報表附註31。

公平值計量及估值過程

就財務報告而言，本集團之可換股債券以公平值計量。本公司董事須就公平值計量釐定合適估值方法及輸入數據。

於估計負債之公平值時，本集團盡可能使用可觀察市場數據。在並無第一級輸入數據之情況下，本集團委聘第三方合資格估值師進行估值。本公司董事與合資格外聘估值師緊密合作，以設立模式適用之估值方法及輸入數據。

Fair value measurements and valuation process (continued)

The Group uses valuation techniques that include inputs that are not based on observable market data to estimate the fair value of certain types of financial instruments. Note 31 to the consolidated financial statements provides detailed information about the valuation techniques, inputs and key assumptions used in the determination of the fair value of various liabilities.

Changes in subjective input assumptions can materially affect the fair value estimate.

Useful lives of property, plant and equipment and right-of-use assets

The directors of the Company determine the estimated useful lives and related depreciation charges for its property, plant and equipment and right-of-use assets. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment and right-of-use assets of similar nature and functions. It could change significantly as a result of technical innovations and competitor actions in response to severe industry cycles. The management will increase the depreciation charges where useful lives are less than previously estimated lives, or it will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold.

Write down of inventories

The directors of the Company review the ageing analysis of inventories at the end of each reporting period, and makes allowance for obsolete and slow-moving inventory items identified that are no longer suitable for use in production or sales. The directors of the Company estimate the net realisable value for consumables and coals based primarily on the latest invoice prices and current market conditions. The Group carries out an inventory review on a item-by-item basis at the end of each reporting period and makes allowance for obsolete items.

於估計若干類別金融工具之公平值時，本集團採用包括並非根據可觀察市場數據之估值方法。有關用於釐定各種負債公平值之估值方法、輸入數據及主要假設之詳細資料載於綜合財務報表附註31。

主觀輸入數據假設之變動可對公平值估值造成重大影響。

物業、廠房及設備及使用權資產之可使用年限

本公司董事釐定其物業、廠房及設備及使用權資產之估計可使用年限及有關折舊費用。該估計乃基於有關具備類似性質及功能之物業、廠房及設備及使用權資產之實際可使用年期的過往經驗。彼可能由於技術創新及競爭對手為應對嚴峻行業周期採取的行動而發生重大變化。倘可使用年限較先前所估計年限為短，則管理層將增加折舊費用，或撤銷或撇減已棄置或出售之技術過時或非策略性資產。

存貨撇減

本公司董事於各報告期間結束時檢討存貨賬齡分析，並就確定為不再適合用作生產或銷售之過時及滯銷存貨項目作出撥備。本公司董事主要根據最近期發票價格及當時市況估計該等消費品及煤炭之可變現淨值。本集團於各報告期間結束時進行逐項存貨盤點，並就過時項目作出撥備。

Provision for close down, restoration and environmental costs

The provision for close down, restoration and environmental costs is determined by the directors of the Company based on their past experience and best estimation of future expenditures, after taking into account existing relevant in the Mainland China regulations. However, in so far as the effect on the land and the environment from current mining activities becomes apparent in future periods, the estimate of the associated costs may be subject to revision from time to time.

Recognition of stripping activity assets

The recognition of stripping activity assets is determined by the directors of the Company based on their past experience and best estimation of future benefits associated with the stripping activities incurred. The estimate may be influenced by changes of actual geological conditions, coal reserves and future production plan.

Recognition of deferred tax assets

The Group has recognised deferred tax assets which arose from deductible temporary differences. The realisability of the deferred tax assets mainly depends on whether it is probable that future taxable profits or taxable temporary differences will be available against which the assets can be utilised. In cases where the actual future taxable profits or taxable temporary differences generated are less than expected, a reversal of deferred tax assets may arise, which will be recognised in profit or loss for the period in which such reversal takes place.

估計不明朗因素之主要來源(續)

關閉、復墾及環境成本撥備

關閉、復墾及環境成本撥備由本公司董事考慮現有相關中國內地規例後，根據過往經驗及對未來支出之最佳估計釐定。然而，在目前採礦活動於未來期間對土地及環境之影響變得明顯之情況下，有關成本之估計可能須不時予以修訂。

剝離活動資產之確認

剝離活動資產之確認乃由本公司董事根據其過往經驗以及對有關所發生剝離活動的未來收益的最佳估計而確定。該估計可能會受到實際地質條件、煤炭儲量及未來的生產計劃變化的影響。

確認遞延稅項資產

本集團已確認遞延稅項資產，其源自可扣減暫時差額。遞延稅項資產之可變現性主要取決於是否存在未來應課稅溢利或應課稅暫時差額可供抵銷可動用資產。倘所產生之實際未來應課稅溢利或應課稅暫時差額較預期為低，則可能出現撥回遞延稅項資產，其於有關撥回發生期間於損益確認。

Information reported to the executive directors of the Company, being identified as the chief operating decision makers (“CODM”), for the purposes of resource allocation and assessment of segment performance focuses on types of goods delivered or services rendered. No operating segments identified by the CODM have been aggregated in arriving at the reportable segments of the Group.

Specifically, the Group’s reportable and operating segments are as follows:

- (1) Coal mining business segment: mining and sales of coals in the Mainland China;
- (2) Renewable energy business segment: service income from renewable energy solutions in Malaysia; and
- (3) IT Services business segment: IT consultancy and technical services (including sales of IT hardware products) and IT outsourcing services in Hong Kong, Malaysia, Singapore and the United Kingdom (the “UK”).

The accounting policies of the operating segments are the same as the Group’s accounting policies described in Note 2 to the consolidated financial statements.

Segment revenue represents revenue derived from (i) coal mining business; (ii) renewable energy business; and (iii) IT Services business.

Segment results, which are the measures reported to the CODM for the purposes of resources allocation and assessment of segment performance, represent the profit earned or loss incurred by each segment without allocation of changes in fair value of contingent consideration receivables and convertible bond designated as financial liabilities at FVPL and exchange gain or loss.

- (3) 資訊科技服務業務分部: 於香港、馬來西亞、新加坡及英國(「英國」)之資訊科技諮詢及技術服務(包括銷售資訊科技硬件產品)及資訊科技外包服務。

經營分部之會計政策與綜合財務報表附註2所述之本集團會計政策一致。

分部收益指(i)煤礦業務; (ii)可再生能源業務; 及(iii)資訊科技服務業務所產生之收益。

分部業績乃就資源分配及分類業績評估向主要營運決策者報告之措施。分部業績指各分部賺取的溢利或招致的虧損(並未分配應收或然代價及指定為按公平值列賬並在損益內處理之金融負債之可換股債券之公平值變動及匯兌收益或虧損)。

Segment assets include property, plant and equipment, intangible assets, goodwill, prepayments for acquisition of property, plant and equipment, deferred tax assets, inventories, trade and other receivables and cash and cash equivalents. All assets are allocated to operating segments other than unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities include convertible bond designated as financial liabilities at FVPL, trade and other payables, interest-bearing borrowings, promissory notes, lease liabilities, mining right payables, tax payables, provision for close down, restoration and environmental costs and deferred tax liabilities. All liabilities are allocated to operating segments other than unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

In addition, the directors of the Company consider that the Group's place of domicile is Hong Kong, where the central management and control is located.

Malaysia corporate income tax is calculated at the rate of 24% of the estimated assessable profits of the Group’s entities in Malaysia arising from Malaysia during the years ended 31 March 2022 and 2021. During the year ended 31 March 2022, Malaysia incorporated entities with paid-up capital of Malaysia Ringgit (“RM”) 2.5 million or less and gross business income of not more than RM50 million enjoy tax rate of 17% (2021: 18%) on the first RM600,000 (2021: RM600,000) and remaining balance of the estimated assessable profits at the standard rate.

During the year ended 31 March 2021, the Group recognised an over provision of Malaysia corporate income tax in respect of prior years of approximately HK\$180,000.

During the year ended 31 March 2022, Singapore CIT is calculated at the rate of 17% (2021: 17%) of the estimated chargeable income of the Group’s entities in Singapore arising from Singapore with no rebate (2021: no rebate).

(i) Mining right and stripping activity assets

The directors of the Company conducted impairment review of the mining right and stripping activity assets at the end of each reporting period or when impairment indicator exists. In such connection, the Company engaged ValQuest Advisory Hong Kong Limited ("ValQuest"), an independent professional valuer, to assess the VIU of CGU of the coal mines related non-current assets, including property, plant and equipment, mining right, stripping activity assets and prepayments for acquisition of property, plant and equipment of the individual mine site, of the coal mining business of the Group (the "Coal Mining Assets") for the purpose of impairment testing as at 31 March 2022 and 2021.

During the years ended 31 March 2022 and 2021, with reference to valuations conducted by ValQuest using discounted cash flow method, the directors of the Company expected that the VIU of the Coal Mining Assets is higher than its carrying amount by approximately HK\$32,865,000 (2021: approximately HK\$23,773,000) and thus concluded that no impairment loss was recognised during the years ended 31 March 2022 and 2021.

The directors of the Company had also considered the following factors and concluded that no reversal of impairment loss was required for the years ended 31 March 2022 and 2021:

- (a) the impairment loss recognised in previous years was related to the Coal Mining Assets of Kaiyuan Mine (as defined in Note (i) below) before the completion of Optimization and Upgrading Plan (as defined in Note (ii) below);

In light of the current mining right which is expiring in August 2049 as disclosed below, the directors of the Company are of the opinion that, based on past experience and current laws and regulations in the Mainland China, the Group is eligible to further renew the mining right without incurring significant incremental cost, given the Group continues to comply with the requirements as required by the relevant local authorities in the Mainland China. In this connection, when assessing the VIU of the Coal Mining Assets, the directors of the Company adopted a cash flow forecast which covers beyond the expiry date, representing the remaining periods of the mine until the expected coal reserves of the mine is fully utilised.

Having considered the sensitivity analysis about the possible outcomes for any mining activities after August 2049 and the likelihood of successful renewal of the mining right with reference to a legal opinion issued by the lawyer in the Mainland China, the directors of the Company considered the risk exposed to the renewal of mining right after August 2049 may not have significant impact on the VIU of the Coal Mining Assets.

In assessing the VIU of the CGUs, the future cash flows of the coal mining business are discounted to the related present values using a pre-tax discount rate that reflects current assessment of the time value of money and the risks specific to such business. Parameters used in the projected cash flows included but were not limited to selling prices and sales volumes of coal, production cost and other expenses, capital expenditure, production plan and discount rate, respectively, which reflected the current conditions of the market and the Group and estimated trend in the future. In particular, the Group may revise the annual production plan and the expected sales volumes of coal adopted in the cash flows projection with reference to the latest government policies announced from time to time.

When evaluating the appropriate discount rate for each of the CGUs, the Capital Asset Pricing Model ("CAPM") had been used. Under CAPM, the appropriate expected rate of return was the sum of the risk-free return and the equity risk premium required by investors to compensate for the market risk assumed. In addition, the expected rate of return of the CGUs was expected to be affected by other firm specific risk factors that are independent of the general market. The cost of equity was determined by the risk-free rate, market return and estimated beta of the CGUs and firm specific risk factors. Therefore, the Group may update the inputs of discount rate and other valuation parameters with reference to the latest market information and the firm's specific risk factors based on the most recent available evidences from the relevant appropriate sources, e.g. the competent person's report on mine reserve.

(ii) Optimization and Upgrading Plan

During the year ended 31 March 2012, the Xinjiang Land Department informed the Group that pursuant to the instructions of the National Development and Reform Commission of the Mainland China, the Xinjiang Land Department is planning a management restructuring of different coal mines in the Xiheishan Mining Area (the "Optimization and Upgrading Plan"), where the Group's Kaiyuan Mine and Zexu Open Pit Coal Mine (the "Zexu Mine") are situated.

On 14 March 2012, a proposal (the "Proposal") was issued by the People's Government of Mulei Kazak Autonomous County, where the Group's Kaiyuan Mine is located, to the Administrative Bureau of Coal Industry of Changji Prefecture (the "Changji Administrative Bureau"). According to the Proposal, which is part of the Optimization and Upgrading Plan, the mining area of the Kaiyuan Mine, where the Group is now conducting mining activities, is proposed to be increased to 4.12 square kilometers, with the estimated additional coal resources of approximately 131.18 million tonnes. In the Proposal, it is also stated that the production capacity of the Kaiyuan Mine will increase from 0.9 million tonnes per year to 3 million tonnes per year.

(ii) 優化升級方案

截至二零一二年三月三十一日止年度，新疆國土資源廳知會本集團，根據中國內地國家發展和改革委員會之指示，新疆國土資源廳已為西黑山礦區內不同煤礦作出管理重組規劃(「優化升級方案」)，本集團之凱源煤礦及澤旭露天煤礦(「澤旭煤礦」)位於該礦區內。

於二零一二年三月十四日，本集團凱源煤礦所在之木壘哈薩克自治縣人民政府向昌吉州煤炭工業管理局(「昌吉管理局」)發出建議(「建議」)。根據為優化升級方案一部分之建議，本集團正進行開採活動之凱源煤礦之開採面積建議增至4.12平方公里，估計額外煤礦資源約為131.18百萬噸。於建議中，亦列明凱源煤礦之產能由每年0.9百萬噸增至每年3百萬噸。

The Group received a letter dated 13 June 2012 issued by the Changji Administrative Bureau (the “13 June Letter”) informing the updated status of the Management Restructuring Plan (as defined in the announcement of the Company dated 11 November 2011). According to the 13 June Letter, the following proposals in relation to the Group’s Kaiyuan Mine and Zexu Mine (the “Updated Proposals”) have been submitted to the working group head office for coal industry structural upgrade work of Xinjiang Uygur Autonomous Region for consideration and approval:

- the Group’s Kaiyuan Mine will be restructured and upgraded, and the exploration rights in the Zexu Mine granted to the Group will be terminated; and
- the mining area of the Kaiyuan Mine, where the Group is now conducting mining activities, is proposed to be increased from 1.1596 square kilometers to 4.12 square kilometers, with the estimated additional coal resources of approximately 131.18 million tonnes.

Pursuant to the terms of the transfer agreement (the “Transfer Agreement”) on 2 December 2019 entered into between the Xinjiang Land Department and 木壘縣凱源煤炭有限責任公司 (Mulei County Kai Yuan Coal Company Limited*, “Kaiyuan Company”) in respect of the new mining right with an enlarged mining area for a term of 30 years from August 2019 to August 2049 (the “Enlarged Kaiyuan Mine”), Xinjiang Land Department agreed to sell and Kaiyuan Company agreed to purchase, the mining permit in respect of the Enlarged Kaiyuan Mine, at an aggregate consideration of approximately RMB160,978,000 (equivalent to approximately HK\$177,221,000), which shall be settled in cash and paid by Kaiyuan Company to Xinjiang Land Department in fifteen instalments over a period of 15 years. As part of the Transfer Agreement, Kaiyuan Company is also required to pay an additional supplemental resources fee of approximately RMB76,503,000 (equivalent to approximately HK\$85,688,000) to Xinjiang Land Department within 30 days from signing of the Transfer Agreement for the accumulated unpaid output of 19.8 million tonnes of coal of Kaiyuan Mine up to 30 April 2019. The amount was fully settled and recognised in profit or loss during the year ended 31 March 2020.

本集團接獲昌吉管理局就通知管理重組規劃(定義見本公司日期為二零一一年十一月十一日之公告)之最新情況所發出之日期為二零一二年六月十三日之函件(「六月十三日函件」)。根據六月十三日函件，下列有關本集團凱源煤礦及澤旭煤礦之建議(「更新建議」)已提呈新疆維吾爾自治區煤炭產業結構優化升級工作領導小組辦公室作審批：

- 本集團之凱源煤礦將予以重組及升級，而授予本集團之澤旭煤礦勘探權將予以終止；及
- 本集團正進行開採活動之凱源煤礦之開採面積建議由1.1596平方公里增至4.12平方公里，估計額外煤礦資源約為131.18百萬噸。

根據新疆國土資源廳與木壘縣凱源煤炭有限責任公司(「凱源公司」)於二零一九年十二月二日訂立之內容有關年期由二零一九年八月至二零四九年八月為期30年之經擴大採礦面積之新採礦權(「經擴大凱源煤礦」)出讓協議(「出讓協議」)的條款，新疆國土資源廳同意出售而凱源公司同意購買經擴大凱源煤礦的採礦許可證，代價合共約為人民幣160,978,000元(相等於約177,221,000港元)，須以現金結算並由凱源公司於十五年期間內分十五期向新疆國土資源廳支付。作為出讓協議的一部分，凱源公司亦須於簽出讓協議後30日內就凱源煤礦截至二零一九年四月三十日之累計未付產出量19,800,000噸支付額外補充資源費約人民幣76,503,000元(相等於約85,688,000港元)。該金額已於截至二零二零年三月三十一日止年度悉數償付及於損益中確認。

(ii) Optimization and Upgrading Plan (continued)

On 6 December 2019, the Transfer Agreement was duly executed by Xinjiang Land Department and Kaiyuan Company.

According to the Transfer Agreement, the estimated coal reserves of the Enlarged Kaiyuan Mine are 41.6433 million tonnes for the mining life of 30 years as at the date of acquisition.

(iii) Renewable energy service contract

The renewable energy service contract relates to the Renewable Energy CGU (as defined in Note 14 to the consolidated financial statements) and represented a legally binding service agreement entered into between NEFIN Technologies (Malaysia) Sdn. Bhd. (“NEFIN Technologies”), a wholly-owned subsidiary of NEFIN Leasing Technologies Limited (“NEFIN Leasing”) (together referred to as “NEFIN Group”), and its customer, which was acquired as part of the Group’s acquisition of NEFIN Group during the year ended 31 March 2019 and was initially recognised at its fair value at acquisition date with reference to a professional valuation conducted by ValQuest using discounted cash flow method. The remaining useful life of the renewable energy service contract as at acquisition date is determined by the Group to be 25 years.

The renewable energy service contract is tested for impairment at least annually and has been included in the Renewable Energy CGU for impairment assessment of goodwill.

As at 31 March 2022 and 2021, the directors of the Company estimated that the recoverable amount of renewable energy service contract exceed its carrying amount and thus concluded that no impairment loss was recognised during the years ended 31 March 2022 and 2021.

新能源租賃科技有限公司（「新能源租賃」）的全資附屬公司NEFIN Technologies (Malaysia) Sdn. Bhd.（「NEFIN Technologies」）（統稱「新能源集團」）與其客戶訂立涉及可再生能源現金產生單位（定義見綜合財務報表附註14）的可再生能源服務合約（構成具有法律約束能力的服務協議），合約於截至二零一九年三月三十一日止年度獲收購為本集團收購新能源集團的一部分，並初步使用貼現現金流量法參照中誠達行進行的專業估值按其收購日期的公平值確認。本集團釐定於收購日期，可再生能源服務合約的剩餘可用年期為25年。

可再生能源服務合約每年至少須進行減值測試，並已計入可再生能源現金產生單位進行商譽減值評估。

As part of the acquisition consideration upon the completion of the acquisition of Harbour Group, the vendor of Harbour Group (the “Vendor of Harbour Group”) has agreed to guarantee to the Group that the audited consolidated net profit generated from operating activities of Harbour Group in its ordinary and usual course of business (i.e. the net profit after tax of Harbour Group as to be shown in the audited accounts of Harbour Group), prepared in accordance with HKFRSs issued by the HKICPA for the relevant financial period by the auditors appointed by the Group (the “Net Profit”) for each of the financial years ended 31 December 2018, 2019 and 2020 (each such 12-month period is referred to as a “PG 12-Month Period”) shall be no less than HK\$7,200,000 per annum (the “Guaranteed Profit”). In the event that the Net Profit during the PG-12 Month Period is less than the Guaranteed Profit, the Vendor of Harbour Group unconditionally and irrevocably undertakes and guarantees, as a continuing obligation, to pay such shortfall multiplying the ratio (1.13) (the “Shortfall Amount”) presented as below:

The initial valuation of the contingent consideration receivables is valued by Peak Vision Appraisals Limited ("Peak Vision") in accordance with HKFRS 13 and is mainly based on the latest audited financial information of Harbour Group for the year ended 31 December 2018 and Harbour Group's financial performance forecasts for the years ended 31 December 2019 and 2020 prepared by the management of the Harbour Group. Accordingly, the fair value of the contingent consideration receivables was estimated to be approximately HK\$5,364,000 as at the acquisition date (i.e. 23 April 2019). Monte Carlo Simulation Method is used for the valuation of contingent consideration receivables which is commonly-adopted in the market. It was first introduced to finance in 1964 by David B. Hertz through his Harvard Business Review article, and in 1977, Prelim Boyle pioneered the use of simulation in derivative valuation in his seminal Journal of Financial Economics paper.

The value of contingent consideration receivables is derived from the cash flow compensation as a result of the possibility of failure to meet the Guaranteed Profit by Harbour Group. As such, Peak Vision adopted the Monte Carlo Simulation Method, which is a path dependent model to consider the probability weighted distribution of the possible outcomes and factors the volatility of these outcomes. The Monte Carlo Simulation Method is one of the most commonly adopted valuation methodologies to value contingent receivable or profit guarantee.

The Vendor of Harbour Group shall pay to the Group the Shortfall Amount by way of cash and/or setting off the same amount from the amount owed by the Group under the Promissory Notes (as defined in Note 27 to the consolidated financial statements) after the audited financial statements are issued by the auditors of Harbour Group for the relevant PG-12 Month Period.

In the event that the Net Profit for the PG-12 Month Period exceeds the Guaranteed Profit, such excess amount shall not be carried forward to meet the Guaranteed Profit for the subsequent period.

於港海集團核數師刊發相關溢利保證十二個月期間之經審核財務報表後，港海集團賣方應透過現金及／或自本集團於承兌票據(定義見綜合財務報表附註27)項下結欠金額抵扣有關金額之方式向本集團支付不足金額。

According to the audited financial statements of Harbour Group for the year ended 31 December 2020 issued on 31 March 2021, the Net Profit of Harbour Group was approximately HK\$4,954,000 and was lower than the Guaranteed Profit by approximately HK\$2,246,000. The Shortfall Amount calculated based on the above formula equals to approximately HK\$2,538,000 and the Shortfall Amount was transferred to guaranteed profit compensation receivables during the year ended 31 March 2021 and it was settled by (i) cash of approximately HK\$138,000; and (ii) setting off from Promissory Note 3 (as defined in Note 27 to the consolidated financial statements with principle amount of HK\$2,400,000) during the year ended 31 March 2022.

Upon the issuance of the audited financial statements of Harbour Group for the year ended 31 December 2020, the obligation of the Vendor of Harbour Group in respect of the profit guarantee under the sale and purchase agreement was fulfilled. Mining activities may result in land subsidence or damage, which could lead to losses to the residents of the mining areas. Pursuant to the relevant Mainland China regulations, the Group is required to make compensation payments to the residents for their losses resulting from land subsidence or damage, or to restore the mining areas back to certain acceptable conditions.

Under existing legislation, the directors of the Company believe that there are no probable liabilities that will have a material adverse effect on the financial position or results of operations of the Group. The Mainland China government, however, has moved and may move further towards the adoption of more stringent environmental standards. Environmental liabilities are subject to considerable uncertainties which affect the Group's ability to estimate the ultimate cost of remediation efforts. These uncertainties include: (i) the exact nature and extent of the contamination at various sites including, but not limited to, coal mines and land development areas, whether operating, closed or sold, (ii) the extent of required cleanup efforts, (iii) varying costs of alternative remediation strategies, (iv) changes in environmental remediation requirements, and (v) the identification of new remediation sites.

- (i) During the year ended 31 March 2020, 3 promissory notes with principal amount of HK\$2,400,000 each (“Promissory Note 1”, “Promissory Note 2” and “Promissory Note 3”, together “Promissory Notes”) were issued by the Company to the Vendor of Harbour Group as part of the acquisition consideration upon the completion of the Group’s acquisition of Harbour Group on 23 April 2019 with a fair value of approximately HK\$6,764,000 (aggregate principal amount of HK\$7,200,000) based on the professional valuation performed by Peak Vision. The Promissory Notes bear no interest. The maturity dates of Promissory Note 1, Promissory Note 2 and Promissory Note 3 are 15 business days after the audited consolidated financial statements are issued by the auditors of the Harbour Group for the years ended 31 December 2018, 2019 and 2020, respectively. The effective interest rates of the Promissory Note 1, Promissory Note 2 and Promissory Note 3 were determined to be approximately 0%, 6.65% and 6.78% per annum as at acquisition date (i.e. 23 April 2019).

The Group fully repaid the Promissory Note 1 with principal amount of HK\$2,400,000 as it was matured during the year ended 31 March 2020.

- (ii) In May 2020, the Group fully repaid the Promissory Note 2 with principal amount of HK\$2,400,000 as it was matured and approximately HK\$2,187,000 was settled by offsetting the guaranteed profit compensation receivables during the year ended 31 March 2021. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000 in total. Contributions to the plan vest immediately.

The Company's subsidiaries established in the Mainland China are members of the state-managed retirement benefits scheme operated by the Mainland China government (the "Mainland China Retirement Scheme"). The retirement scheme contributions, which are based on a certain percentage of the salaries of the Mainland China subsidiaries' employees, are charged to the consolidated statement of profit or loss and other comprehensive income in the year to which they are related and represented the amount of contributions payable by these subsidiaries to this scheme.

The total cost charged to the consolidated statement of profit or loss and other comprehensive income of approximately HK\$3,686,000 (2021: approximately HK\$1,670,000) represents contributions payable to the schemes by the Group in respect of the current financial year.

For the year ended 31 March 2022 and 2021, there were no forfeited contributions which were available to reduce the Group's existing level of contributions to the MPF Scheme and the Mainland China Retirement Scheme.

34. 定額供款退休計劃

本集團根據強制性公積金計劃條例為受香港僱傭條例管轄之受聘僱員營辦一項定額供款強制性公積金計劃(「強積金計劃」)。強積金計劃為一項由獨立受託人管理之定額供款退休計劃。根據強積金計劃，僱主及其僱員各自須按僱員相關收入5%向計劃供款，最高每月相關收入合共為30,000港元。計劃供款即時歸屬。

本公司在中國內地成立之附屬公司為中國內地政府營辦之國家管理退休福利計劃(「中國內地退休計劃」)之成員。退休計劃供款根據中國內地附屬公司僱員之薪金若干百分比計算，並於供款有關年度在綜合損益及其他全面收益表內扣除，數額為此等附屬公司應付予該項計劃之供款金額。

於綜合損益及其他全面收益表扣除之總成本約3,686,000港元(二零二一年：約1,670,000港元)指本集團就本財政年度向該等計劃應付之供款。

截至二零二二年及二零二一年三月三十一日止年度，並無可用作扣減本集團現時對強積金計劃及中國內地退休計劃供款金額之已沒收供款。
